I am writing in support of ordinance 2020-25 to establish a Kenai Peninsula Borough Resilience & Security Commission. To me this not only makes sense in a practical way (ie: doing what's right), but it also makes sense economically. The fact is we need to be able to act and act quickly in the face of a changing environment. One need look no further than the fires we have experienced in the last several years, or to our local king salmon stocks, which, along with those statewide, we've seen rapidly dwindle. This would be the perfect opportunity to find ways to adapt to our changing environment, to protect our infrastructure, to examine food security, and to save costs on energy consumption. All of which this commission can investigate, and which will save money in the long run.

I've lived on the Kenai Peninsula for 35 years and have seen many changes. Fires, caused by lightning threatening my home during four of the last eight summers. King salmon stocks declining to the point where, when the season is allowed to open, I no longer choose to fish for these iconic creatures. Warming temperatures in our streams that may threaten other species of fish. The list goes on, and therefore I am asking you to take the responsible steps we need and approve this ordinance. Dear Kenai Peninsula Borough Assembly:

I am writing to offer Chugach Regional Resources Commission's (CRRC) support of the Assembly establishing a Kenai Peninsula Borough Resilience and Security Commission. CRRC was established in 1984 by the seven Tribes of the Chugach Region of Alaska, including the Tatitlek Village IRA Council, Chenega IRA Council, Port Graham Village Council, Nanwalek IRA Council, Native Village of Eyak, Qutekcak Native Tribe, and the Valdez Native Tribe. CRRC was formed as an inter-tribal fish and wildlife commission to collectively address issues of mutual concern regarding stewardship of the natural resources, subsistence, the environment, and to develop culturally appropriate economic projects that promote the sustainable development of the natural resources.

Our member Tribes are located in Prince William Sound and Lower Cook Inlet, a remote region largely limited in travel to small aircraft, charter aircraft and boat travel, with seasonal Alaska marine highway service. Known as Alutiiq, or Sugpiaq, our members are a southern coastal people of Alaska. There are approximately 1,000 Tribal members living in our seven communities,

CRRC is governed by a seven-member board of directors composed of one Tribally elected representative from each community. CRRC is the primary federal contractor for the Chugach Region for natural resource, environment, and economic/community development projects. Programs under the organization include climate change adaptation planning¹, migratory bird management, ocean acidification².


We support the establishment of a solutions-oriented commission to focus on the following issues:

1. Divert materials that would otherwise be discarded in the landfills within the borough, more specifically in our serviced Tribes of Port Graham and Nanwalek to extend the lifetime of landfills and save taxpayer dollars;
2. Improve cost and energy efficiency of buildings and transportation in Port Graham and Nanwalek;
3. Increase use of local, clean energy to (a) modernize electricity generation, storage and distribution; (b) increase energy independence; (c) diversify the grid and reduce supply volatility;
4. Support hazard mitigation planning that accounts for changing environmental conditions on the peninsula;
5. Improve Alaska Native community food security through support of local agriculture, protection of the ecological integrity of fish and wildlife habitat, protection of water resources, and other means;
6. We encourage the use of cost-benefit analyses to understand the impact per dollar sustainability programs can produce. However, natural resources provide a number of non-monetary benefits through the cultural, regulating, supporting ecosystem services they provide in addition to resource extraction. CRRC encourages the Commission to develop a protocol to account for these non-monetary services in cost-benefit analyses.
7. Engage and communicate with the Alaska Native borough communities of Port Graham and Nanwalek to develop sustainable resource initiatives.

A primary purpose would be to formulate policies that generate significant savings and jobs for the borough. Serving as a bridge between our Alaska Native communities, administrators, and experts, this commission will improve the borough's ability to develop effective policies that protect Tribe's interests and those of future generations. A body focused on comprehensive long-range resource planning is needed to protect our private property and public lands; to promote self-sufficiency and protect our business investments; to safeguard the welfare of our families and of our subsistence lifestyles. Please invest in the future of families, businesses and Tribes in the area and establish the Kenai Peninsula Borough Resilience and Security Commission.

Dear Mayor Pierce and Assembly Members,

I am writing to you as a 25-year resident of Seward, a homeowner, employed in informal education. I love the town and community I live in. I wish to support your efforts to keep the Kenai Peninsula a great place to live, raise a family and recreate.

I see a year ahead in which there are many looming issues awaiting the time of Assembly members to parse through. Handling a difficult economic time due to Coronavirus, working to manage changes in Education Funding and our increasing risk of fire on the Peninsula are huge issues that deserve the Assembly's focused attention.

Meanwhile it is likely, due to these pressing issues that other parts of the Assembly's purview may not get the detailed time they need in order to make sound and fiscally supportive choices. I've watched a steady increase in costs to my heating and electric expenses and been introduced to higher rates for my garbage collection, regardless of how much garbage I generate. I've worked in schools and had teachers here in Seward say they don't control the heat in their own buildings so they open a window when the heat gets to be too much on a cold day. I do not blame the assembly for these things but I wonder if time were not an issue might we be able to examine alternatives that cost our communities less and give back more?

I believe the prospect of a Security and Resilience Commission, a voluntary group, could give the Assembly that time. This commission could spend time researching energy alternatives that may use resources we have at hand. Here in Seward a local waterfall may be one source of energy. Wouldn't it be great if we could save space in our landfills by having a compostable materials area? This could generate great soil, save money; even generate money when you sell the soil back to a gardener like myself. But of course these things can't be priorities in a year of so much change and demands on the Assembly's time.

The Security and Resilience Commission could give you that time. They could research how school buildings can be upgraded so they are more efficient. Did you know Anchorage did this and saved 3 million dollars? They could follow up on the USDA's grant program for community composting, which may cut my garbage bill or at least give me a source for great soil. Not to mention greatly increase the life of our landfills.

I appreciate that you are on our Assembly and spending time making the Kenai a great place to live. Please consider a Security and Resilience Commission that can give you time to explore the many options to generate funds and help our Peninsula become an even better place to call home.

I was raised in the Anchorage area, now live in Homer; and in my lifetime have been fortunate to enjoy the Kenai Peninsula, starting in the 1960s. I am very concerned about the changes affecting the Kenai in the past five years particularly. It is unfortunate that while our roads have dramatically improved access to the Kenai from Anchorage (and are improving more in the next few years), the effects of climate change endanger our industries on the Kenai, for example tourism. The effects of climate change on the Kenai Peninsula are huge, and increasing. Final Public Comment on June 16th Assembly Meeting

Sometimes these meetings are hard to take. I didn't speak on Ordinance 2020-25 tonight because I was listening to so many articulate, intelligent, expert comments in support. There was nothing more for me to say. It seemed clear to me that it had widespread support. I read all the other comments online and every comment in opposition either had no more to say than they didn't support it or they were wildly mis-informed and filled with incorrect information. Two of the opposition comments stated that we didn't need the commission because there was already a great plan in place in the Comprehensive Plan which they clearly must not have read or they would know that the great plan strongly advised for this very commission to be formed. Another incorrect opposition statement was that O2020-25 asks for funding from the Borough and the Mayor's comments were also incorrect as part of the goals of the commission is to come up with outside funding through grants. The Mayor and many assembly members said I don't know where we will find the money for anything that the commission suggests but part of what the commission is supposed to do is come up with alternative funding. One commenter asked, "Why do assembly members only ask questions from those who comment in opposition." Well what I have seen is the assembly members are trying to correct mis-information that was stated by the commenter. Even Assemblymen Blakely's main objection that there hasn't been enough community involvement is grossly false. The comprehensive plan was vetted for over 2 years with many community meetings around the borough and the Drawdown Series was held every month for almost a year.

I hear Mr. Bjorkman spout the importance of listening to the experts, scientists, and data on making decisions but unfortunately we live in a community filled with anti-intellectuals who think experts, scientists, and data are fake news, largely thanks to the great orange nope in the white house. 
Dear Assembly,

These free, local volunteer advisors might provide specific actionable proposals for your strategic decision-making. These best practices can be easily bubbled up grassroots by this commission first to build support for your saving money for our Burrough budget in a critical time for saving money, given last year's wildfires, this year's COVID, and closed Kenai River. Fortunately, we have many dedicated researchers living right in our communities who have a keen interest in seeing many of these ideas come to fruition. Building local support and awareness will help you in passing the parts you find worthy. This commission can help focus on solutions for energy, water, food security, waste, and transportation. Currently, there is a lively and bold study group of DRAWDOWN. Aleut elders have informed me that we have less than a decade to right our relations with nature.

Thank you for the opportunity to support our community's resilience and caring carefully for our resources. Our local experts can help us learn how to run a more efficient and cost-aware community on the Kenai of the options. Tonight, I've heard about jobs, food, youth leaders, fishing, climate changes. I point your attention to health challenges. Last year's wildfires that shut down the Sterling Highway were a massive health challenge from poor air quality that caused asthma sufferers to remain indoors all summer. Emergency surgeries had to be flown to Anchorage. Grewingk Glacier is receding 92 feet per year. Mni Wiconi means water is life. Without sufficient water, there is no possibility of living in a dry community. Parts of our Burrough face water shortages. Our state suffered 2.5 million acres of wildfire last year.

This is a voluntary effort. We can reduce waste, increase local funding for public/private partnerships. Had this commission been in place applying for the \$50 K grant mentioned for waste might it have been submitted by these volunteers?

I've lived at 300 Whispering Meadows, Homer for the past 25 years. I commend to you to consider taking the Climate Reality Training free online training led by former Vice President Al Gore for 14 fairly flexible hours between July 18-26. Being further informed may make some of your local votes more certain. I became a Climate Reality Leader and mentor in 2013. It opened my eyes and moved me to walk across the country in the Great March for Climate Action in 2014 from LA to DC, 8 months over 3,500 miles. I heard many stories about weather changing, fracking consequences, and job impacts. I share with you my presentation. I ask that you not share the native clips as they are only for my presenting.

Elisa Russ Testimony Provided Verbally June 16, 2020

Good evening. My name is Elisa Russ and I reside at 53135 McNeil Canyon Rd in Fritz Creek; I have lived on the Kenai Peninsula for 25 years. I am testifying in support of Ordinance 20-25. I am speaking on behalf of myself, however, I was on the Board of the Kachemak Bay Conservation Society as Board members worked to develop a proposal for a Sustainability Commission to present to the Kenai Peninsula Borough Assembly. Many thanks to fellow Board members Penelope Haas, Bjorn Olson, and Roberta Highland for their work on this proposal and also for their efforts to encourage the Assembly to develop a Climate Action Plan for inclusion in the Borough Comprehensive Plan so that local climate adaptation and mitigation measures may be addressed. And especially thank you to Assembly Members Cooper, Dunne, Smalley, and Cox for introducing this ordinance. And I just want to say I was so inspired by the testimony of many of our youth tonight.

Establishing this Sustainability Commission, excuse me – Resilience and Security Advisory Commission, will help to address climate change issues on the Kenai Peninsula. There are several ways this could be accomplished and I will describe a few. Tax incentives could be created to implement renewable energy solutions in homes and businesses; utilizing clean, local energy sources and improving energy efficiency, would result in significant reductions in greenhouse gas emissions from the combustion of fossil fuels, which directly contribute to climate change through global warming. By investing in local agriculture and protecting water resources, food security would be improved, and the Borough carbon footprint could be significantly reduced. Improving public transportation and developing opportunities to use electric vehicles by providing charging stations would also reduce the KPB carbon footprint. Green spaces on borough lands could be managed to provide more shade to protect salmon streams as rising temperatures have killed salmon due to extreme reductions in dissolved oxygen – that is a direct relationship – oxygen comes out of solution as temperatures increase and information collected by Cook Inletkeeper showed record breaking temperatures in 2019 – thanks to Sue Mauger who testified tonight for that data.

It is of the utmost urgency to address climate change issues now – Alaska is being hit especially hard as is obvious for any resident of the Kenai Peninsula when thinking back to July 2019, the hottest month on record in Alaska. The devastating impacts felt by our communities due to last year's warm temperatures including fires, draught with resultant water shortages, and declines in Alaska's fisheries due to warming ocean conditions as seen by recent collapses in Pacific cod commercial fisheries – these impacts can no longer be ignored – it is an extreme threat. We must work to implement mitigation measures in order to survive the climate crisis and the warming of Alaska. This Commission is a necessary body to develop and recommend sustainable solutions for the Kenai Peninsula Borough. Thank you and please vote Yes to give us hope for our future.
