

SUBJECT: Authorizing Award of Contract for Winridge Avenue and Eagle Ridge Court Paving RIAD #WINRD

On June 12, 2015 the Kenai Peninsula Borough Road Service Area formally solicited bids for Winridge Avenue and Eagle Ridge Court Paving Road Improvement Assessment District (RIAD) #WINRD for completion in summer 2015. The invitation to bid was advertised in the Peninsula Clarion June 14, 17 and 22, 2015.

On the due date of June 25, 2015 one (1) bid was received and reviewed to ensure that all the specifications and delivery schedules were met. Knik Construction Company, Inc. was the sole bidder.

Knik Construction Company, Inc. submitted a bid amount of \$178,312.50. The total costs for this project are \$218,739.00, which includes design services, contract services, administrative charges, and contingencies.


The Road Service Area Board at their February 17, 2015 meeting passed Resolution 2015-01 approving to fund expenditures of up to \$111,779.28 associated with the Winridge Avenue and Eagle Ridge Court Paving RIAD. The Kenai Peninsula Borough Assembly at their May 5, 2015 meeting enacted Resolution 2015-016 to form the Winridge Avenue and Eagle Ridge Court RIAD and proceed with the improvement and enacted Ordinance 2014-19-52 appropriating \$223,558.56 to the RIAD.

Your approval to award contract to Knik Construction Company, Inc. is hereby requested. Expenditures for the contract will be charged to account number 832.94912.WINRD.43011.


