I have long thought that tour bridge needed a walkway or widening so pedestrians can safely cross the riliver: not only our children who want to run to The Merc for ice cream but also the slew of fishermen that are here in the summer. A walking/bik e path in that area would also be much appreciated.

Several times I have been driving north near The Merc only to have a car pull out in front of me causing me to slam on my brakes in order to avoid hitting them (I drive at a slower speed in this area.) Cutting the bank back to improve sight when turning left out of The Merc would be a great safety improvement.

A turn lane on the Sterling Hwy at the K-Beach intersection would be one more safety measure that is needed. Many times, while waiting to make a lefthand turn onto K-Beach, I have had cars come upon me too fast precipitating an unsafe swerve around me on the righthand side. A turn lane would solve this dilemma. You may also want to consider a turn lane near the gas station as there have been several cars rear ended over the years as they wait to turn left into Joe's Gas Station just north of the bridge.
