SUBJECT: Authorizing Award of Road Service Area Maintenance Contracts for West Region, Unit 1 and North Region, Units 2, 3, 4 & 5.

On April 2, 2015 the Kenai Peninsula Borough Road Service Area formally solicited proposals for Summer and Winter Road Maintenance for West Region, Unit 1 and North Region Units 2, 3, 4 & 5. The request for proposals was advertised in the Peninsula Clarion April 8, 9 & 15, 2015.

These contracts consist of furnishing all labor, materials and equipment to perform summer and winter road maintenance. These are three-year contracts with an option for two one-year extensions.

On the due date of April 22, 2015 the following proposals were received:

- West Region, Unit 1 received three (3) proposals. River City Construction, G & H Construction and Alaska Scrap & Recycling submitted proposals.
- North Region, Unit 2 received two (2) proposals. D&L Construction Company, Inc. and Commercial Automotive Repair submitted proposals.
- North Region, Unit 3 received two (2) proposals. D&L Construction Company, Inc. and AA Dan's Construction, Inc. submitted proposals.
- North Region, Unit 4 received one (1) proposal from AA Dan's Construction, Inc.
- North Region, Unit 5 received one (1) proposal from Nikiski Equipment.

The evaluation committee evaluated the proposals consistent with the criteria established in the Request for Proposal. The Road Service Area Board at their May 12, 2015 meeting approved unanimously Road Service Area Resolution 2015-04 Recommending Approval of Contracts for Summer and Winter Road Maintenance for the following:
