October 3, 2023 Regular Election

The Borough Canvass Board has canvassed the October 3, 2023 Special Mayoral Election ballots cast by the five By-Mail precincts; the absentee ballots cast by mail, fax and in person; special needs ballots and the questioned ballots cast at the polls on election day. Our findings are as follows:


REVIEW OF PRECINCT MATERIALS




