**KENAI PENINSULA BOROUGH  
RESOLUTION 2021-072**

**A RESOLUTION UPDATING THE KENAI PENINSULA BOROUGH SCHEDULE OF  
RATES, CHARGES AND FEES, PURSUANT TO KPB 1.26**

- WHEREAS,** the Seldovia Recreational Service Area (“SRSA”) was formed pursuant to Kenai Peninsula Borough (“Borough”) Ordinance 2011-28 and voter approval in the October 2011 regular election to furnish recreational services with the service area; and
- WHEREAS,** the SRSA utilizes the Sea Otter Community Center (“SOCC”) to provide its services; and
- WHEREAS,** services include, but are not limited to, senior citizen and youth programs, musical instruction and practice, field trip accommodations for visiting schools, facility rental for organizations and individual meetings and celebrations, adult education, nature education, and outdoor activities; and
- WHEREAS,** the borough assembly previously authorized the renewal of a contract, effective July 1, 2021, with the City of Seldovia (“City”) to manage the SOCC; and
- WHEREAS,** during budget approval, the assembly approved an updated schedule of fees, rates and charges; and
- WHEREAS,** as part of the management of the SOCC the City continuously reviews usage as well as community and program needs, which led to a request to update the schedule in order to better serve the taxpayers within the service area; and
- WHEREAS,** the proposed rates are comparable to rates charged elsewhere in the area and will help ensure that the SOCC offers additional community-based programming; and
- WHEREAS,** SOCC strives to find ways to continue to provide recreation to service area members at no cost or a very minimal cost and these fees reflect those goals; and
- WHEREAS,** as much as possible the fees proposed are minimal to ensure replacement of well-used items with a focus on deposits to ensure return of items rather than fees for use; and
- WHEREAS,** the Seldovia Recreational Service Area board, at its meeting held on August 3, 2021, recommended approval of this resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Schedule of Rates, Charges and Fees for the Seldovia Recreational Service Area, Sea Otter Community Center are amended, to include the following items:

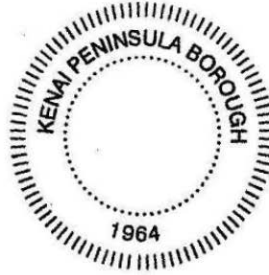
