SUBJECT: Authorization to Award Contract for ITB17-041 Igloo Avenue, Dana Bayes Street #2, Miracle Avenue & Sun Dew Circle Project No. W7IGL

The Purchasing and Contracting Office formally solicited bids for Igloo Avenue, Dana Bayes Street #2, Miracle Avenue & Sun Dew Circle Project No. W7IGL. Bid packets were released on May 11, 2017 and the invitation to bid was advertised in the Peninsula Clarion on May 11, 2017.

The project consists of furnishing all labor, materials and equipment to upgrade these roads. Work may include roadbed widening, roadbed repair, embankment construction, subgrade modifications, drainage, ditching and clearing.

On the due date of May 25, 2017, eight (8) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$443,871.30 was submitted by CIC, Inc. The total cost for this project is \$560,500.00 which includes design services, contract services, inter-department charges, and contingencies.

This project has been approved through the Road Service Area Board at their January 24, 2017 meeting approving road projects be included as FY17 capital improvement projects.
