NO A “no” vote means you oppose borough ordinance 2020-24, providing for vote-by-mail borough elections with in-person voting available at vote centers for absentee ballots and for voters unable to vote by mail.” and

PUBLIC COMMENTS AND PUBLIC PRESENTATIONS

ASSEMBLY COMMENTS

Assembly Member Blakeley stated he appreciated the Mayor and the Directors' work on the FY2021 budget. He stated he was glad the notice of reconsideration was given for Ordinance 2020-24. He wished everyone a good weekend.

Assembly Member Johnson congratulated the Mayor and staff on a well presented budget. Mr. Johnson also stated he received an email from Deputy Borough Attorney, Patty Burley regarding the leg work needed prior to the Anchor Point Ninilchik expanded service area vote at the next regular election. Assembly Member Johnson stated his concerns with the COVID-19 borough cases increasing.

Assembly Member Dunne stated he was glad to see the support for hybrid vote by mail, even though notice of reconsideration was given. He shared his memories of when legalizing marijuana was discussed and how contentious it was; and stated, now the industry appears to be functioning well and also generated tax dollars. He stated he felt vote by mail also fell in that category, and felt once people had options to cast their vote, they would like it and it would be successful. Mr. Dunne stated we should be cautious as the COVID-19 cases were on the rise.

Assembly Member Smalley thanked everyone for their patience with a long two-day long meeting and for their testimony regarding the budget and vote by mail. He stated the budget process was very successful and thanked the Mayor for the budget as presented. He thanked the Clerk's Office for their hard work. He wished Chief

Baisden Happy Birthday.

Assembly Member Hibbert thanked the administration and departments for all their work on the budget. He also thanked Dan Nelson, Emergency Manager and Brenda Ahlberg, Public Information Officer for keeping the borough informed regarding COVID-19. Mr. Hibbert thanked the Clerk's Office and the IT Department for all their work in order for the Assembly to continue meeting in a safe manner. He thanked everyone for their participation and testimony on the Zoom platform. He also thanked his fellow assembly members for the great discussion the past two days.

Assembly Member Cox shared his thoughts regarding the importance of perceptions.

Assembly Member Bjorkman stated he was bringing forward a resolution to discuss conducting borough meetings in person.

President Cooper stated to not only remember perception, but also patience and grace. She stated that she liked that the assembly could disagree on matters but members were always respectful with one another. She reminded members of meeting decorum.

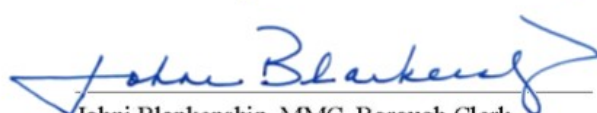
