


CPH Net Patient Revenue – FY2023







CPH Net Income / (Loss) – FY2023






Community Benefit – FY2023 Charity Care & Bad Debt






Uncompensated Care Trend (Charity & Bad Debt, in thousands of Dollars)


Charity Care & Bad Debt - FY 2023

• \$2.8 million in Net Cash Transfers to Plant Replacement Fund



Transfers to Plant Replacement & Expansion Fund

- PREF account balance at 3/31/2023 = \$81,180,528
- CPH Days Operating Cash on Hand at 3/31/2023 totaled 76.23 days
- Amount transferred to PREF in FY23 as of 3/31/2023 totaled \$2,814,320
 - \$2,814,320 in August 2022 for quarter ending 6/30/22

Central Peninsula Hospital has been recruiting Nurse Practitioners and Physician Assistants to provide capacity and access at our family practice and specialty clinics. Supervised by clinic physicians, this new model will provide additional appointment times that will free up clinic physicians to provide space for new patients.

Grant Funding of \$150,000 for KPB School District Counselors
