Mike Moore - Stated that he was present to address slanderous stuff made about SVAC. He did not know where it was coming from or why it was said, and that some of it was wrong. Mike stated that someone was saying that SVAC was not operating at a EMT III scope, saying he doesn't know what that means, there is a EMT III on every ambulance. Not all patients get EMT III treatment because not all patients need EMT III treatment

Mike Moore repeated that he did not know where some of this stuff is coming from. The person making the claim that we were going down the wrong road was, until two years ago, SVAC's training officer. Mike followed that if we are going down the wrong road, he needs to look back and see what the training was. Mike Moore stated that they had never missed a call in Bear Creek.

Mie stated that things are a little tight at SVAC right now, but they still have six or seven EMT IIIs, and five or six EMT Is. Mike also stated that SVAC was looking to increase several of the responders to EMT II and one to EMT III.

Mike mentioned that as of the first of the month, SVAC has new standing orders.

James Sheehan - Asked Mike Moore what the relationship with Bear Creek was like.

Mike responded that he thought it was good. Mike Moore finished by saying that SVAC's door is open if there is a desire to meet and discuss any issues. He stated that they support Bear Creek and they hope Bear Creek supported them.

BOARD COMMENTS TO PUBLIC COMMENTS AND PRESENTATIONS

Doyle Brueckner - Asked for further clarification concerning the comments about SVAC not providing at the level they were supposed to.

Richard Brackin stated that SVAC has not been providing all of the standards of care associated with the EMT III level. One example was the drugs that should be carried on an ALS ambulance are not, or were not until recently carried on SVAC ambulances, limiting the care that can be provided. Richard also stated that in addition to the concerns over care provided was the lack of educational platform that is provided for certifications, falling responder numbers, and the extreme age of many responders.

James Sheehan - Stated that he did not know the in's and out's of the SVAC issues, but that we needed to focus on what we want. Mabey we can help train some of their folks and build our relationship.

Jeffrey Wolf - Applauded the work done by Bear Creek and Seward Fire. The amount of training being provided has been a good thing.
