RE: Authorization to Award a Contract for ITB19-001 Heights Lane and Hillside Drive Project No. NSHEI

The Purchasing and Contracting Office formally solicited and received bids for ITB19-001 Heights Lane and Hillside Drive, Project No. NSHEI. Bid packets were released on July 11, 2018 and the Invitation to Bid was advertised in the Peninsula Clarion on July 11, 2018.

The project consists of furnishing all labor, materials and equipment to upgrade these roads. Work includes, but is not limited to, roadbed widening, subgrade modification, embankment construction, drainage, ditching and clearing.

On the due date of July 31, 2018 bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$288,525.45 was submitted by KEE Construction, of Cooper Landing, Alaska. The total cost for this project is \$362,325.79, which includes design services, contract services, inter-department charges and contingencies.

This project has been approved through the Fiscal Year 2018 Budget Heights Lane and Hillside Drive, Project No. NSHEI Capital Improvement Project.
