Don't make them doubt their value to our cities. Some people have a gender identity that defies existing classification, but that doesn't mean they deserve to be segregated.

In no way is it an absolute truth that all transgender girls have a physical advantage. Trans girls come in all sizes. And some cis girls are stronger than others. I believe there has always been room for diversity of physical development among growing, student athletes. Let all of the girls, cis and trans, excel and learn to compete! The idea here that scholarship money must not be

awarded to trans girls is discriminatory.

This proposed rule change will butt up against privacy protections in the State Constitution. Do not empower coaches and parents to become tyrannical in investigating the gender identity of other people's children! This proposal could add to bullying, rumor spreading, name calling, and even the exclusion of some students from activities. Is the plan to root out trans girls that pass as cisgender girls? How (and how come)?

What about dance team and cheer? Are you seriously going to keep some students out of these competitions on the basis of sex? That would be very cruel. It is sex-based discrimination.

Balancing Competitive Fairness and Safety for All Who Compete.”**

There are very few issues which would prompt me to write an opinion; however, this issue is one in which I have unique experience directly related to Kenai Peninsula athletes and Alaska athletes. In their behalf, I must speak.

I was Soldotna High School's first Head Wrestling Coach from 1980-87. I was part of the Skyview High School Wrestling Coaching Staff from 1990-2005 when I retired after 30 years of teaching and coaching.

The genuine courage, sacrifice and commitment made by girls who competed in ASAA Wrestling during this period was heroic. I worked with girls in Team Practice, in Duals and at Tournaments. I traveled with them all over the State as part of the Squad during the season. We all stayed at Schools, often in classrooms, separated by gender with appropriate staff. The struggle that girls faced in the Practice Room, at first, as well as the resistance at some schools to having girls wrestle against their male team-members, was nothing short of monumental; but the girls dealt with it with “nobility and grace under fire.”

While coaching as part of the Skyview Wrestling Squad, under the direction of Head Coach Neldon Gardner, recently inducted into the National Wrestling Hall of Fame, I got to have the great experience of watching THE FIRST GIRL IN ALASKA place in a State Wrestling Championship Tournament. She had two brothers who were Alaska State Champions. I then got to be part of the Skyview Wrestling Program that had THE FIRST GIRL IN THE NATION win a State Championship. Competitive Wrestling is now divided by gender in Alaska.

To allow, biologically born boys, to compete now and in the future in Alaska sports designated for “Girls” would be a travesty and would greatly disrespect the effort, nobility and grace shown by girls all over this State. As a former athlete and Kenai Peninsula Borough coach, I say, it must not be allowed as it is “fundamentally unbalanced, competitively unfair and unsafe.”

Please consider my experience in making your decision. I am attending a nationally known Speaker in Kenai tonight at 7 PM or I would have personally attended your meeting.

Boys in Girls sports.

This is the question before the Borough tonight. I am guessing during the public comment period there will be lots of discussion about the harm this resolution can cause to boys who struggle with their sexual identity. I am not opposed to trying to do what is best for those who struggle with sexual identity. Far from it. I think they need all the care and attention we can possibly give that will benefit them.
