Domestic Animal Protection League

- Proposed Goal:
- Help and protection for
 - **ABANDONED, ABUSED, NEGLECTED AND STARVING ANIMALS...**
- ...in the Kenai Peninsula borough, outside the city limits.
- **Currently there is NO PROTECTION for these animals.**
- What we are NOT proposing:
- No borough wide Animal Control
- No leash laws
- No licensing your pets
- We are not even interested in enforcing rabies vaccinations which are required by state law.

Spring 2014

- Borough Assembly calls for an Advisory Vote.
- Question 1) **IS THIS NEEDED?**
- Shall the borough exercise limited control powers for the purpose of domestic animal rescue and care related to rescue in the areas of the borough outside the cities?
- Question 2) **HOW SHOULD IT BE FUNDED?**
- Shall there be a mill rate of 0.02 on properties outside of cities to pay non-area wide domestic animal rescue and care related to rescue services.
- We found two primary opinions:
 - 1) **ITS ABOUT TIME**
 - We replied) “We Agree!”
 - 2) **I DON’T WANT ANYMORE GOVERNMENT IN MY BUSINESS**
 - We replied) “If you’re taking care of your animals there will be no additional government intrusion in your life.”

There is an Undisputed Link between Domestic Violence and Animal Abuse.

- * April is National Child Abuse Prevention month.
- * On April 10, 2015, Channel 2 News in conjunction with Alaskan's Children Trust presented a report which stated;
- * “Alaska has one of the highest rates of CHILD ABUSE IN THE ENTIRE COUNTRY.”
- **FACTS:**
- * Abusers of animals are FIVE TIMES as likely to harm humans.
- * Nearly HALF of the victims who stay in violent households do so because they are afraid for their animals.
- Countless more never leave the home for this very reason.
- * The link between violence against humans and animals is clear.

- * When a child harms animals it can indicate that serious abuse has been inflicted on the child; Consequently, animals are abused in nearly all households in which children have been abused.
- * According to the Center for Disease Control Prevention (CDC) Domestic violence can include; physical, sexual, emotional violence and **THREATS**.
- * Killing, harming, or THREATNING to do animals harm are weapons abusers use to silence and MAINTAIN CONTROL over victims.

An Undeniable Link

- * Many victims entering shelters report abusers have hurt, killed or threatened the family pet.
- * Victims often admit an animal being abused before they admit their own suffering.
- * Animal Cruelty Investigations frequently unravel **CHRONIC DOMESTIC ABUSE**.
 - (published by animal league defense fund)

More Stats

- * A published paper from the law office of Carol Ryder, a member of the Suffolk County New York Bar association states:
- * Stats on animal abuse show a sharp correlation between animal abuse and other crimes including; Rape, Robbery, Murder, Sexual Homicide, Domestic Abuse and more.
- * Studies show 100% of sexual homicide perpetrators like Jeffery Dahmer, started by abusing animals.

2 Cases from New York

- **1) Michael Vick:**
- Served “Little Time” for running a vicious dog fighting ring.
- **2) Chester Williamson:**
- Set a cat named BUSTER on fire, killing the cat and Williamson served ONLY a one year MISDEMEANOR sentence.
- Due to the outrage over these cases;
- The New York State Agricultural Committee proposed a bill - #A8444
- Due to recognizing the animal abuse tie to other crimes connection, they require psychiatric intervention for all animal abusers, even juveniles.
- Also passed, was Bill AML – S353- A “BUSTERS LAW” Raising the maximum penalty for aggravated cruelty to a companion animal from a one year MISDEMEANOR to a two year FELONY CHARGE.
- Animal Abuse is a predictor of other crimes including; Domestic Abuse, Murder, Rape and more.

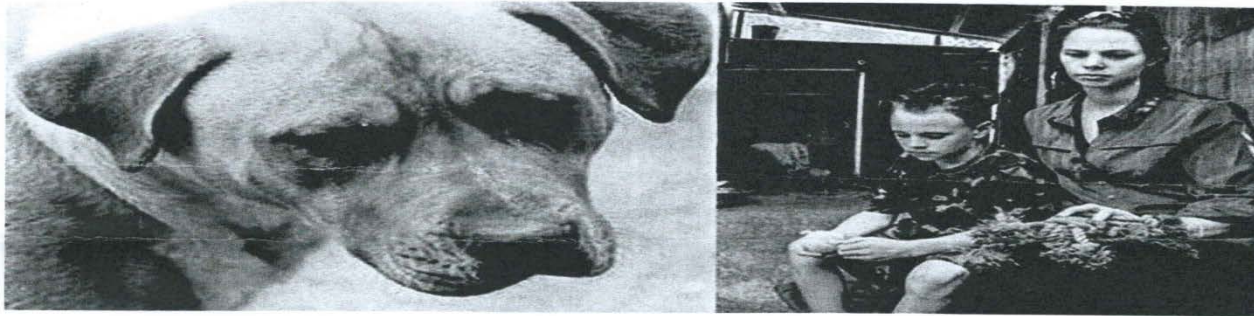
HERE'S WHY IT MATTERS

- * 68% of battered women reported violence towards their animals. 87% happened in the presence of the women – 75% in front of their kids.
- * Abusers kill, harm or threaten children's pets to coerce them into sexual abuse or to force them to remain SILENT about this abuse.
- For many battered women, pets are a source of comfort and strong emotion support.
- Investigation of animal abuse is often the first point of Social Services intervention for a family in trouble.

Costs for a Seized Animal

\$45 per dog to de-worm and rid ear mites

\$165 per male to neuter

\$185 per female to spay

\$18.75 per rabies shot

\$10 per Parvo/Distemper shot

\$10 per day, to feed, and house an animal

Adoption Fee: \$50 - \$150

[Depending on the animal]

“What Will It Cost?” [Equine]

- **Chris Heintz...**
- ...has been rescuing animals for over 30 years.
- Average Rescues – 10 to 12 per year
- **Costs to rehabilitate a rescued horse....**
- \$10 a day to feed a horse [$\frac{1}{2}$ bale of hay]
- \$15 a day to feed a horse [grain and vitamins]
- \$12 de-worming per animal [4 treatments]
- \$12 delousing per animal [2 treatments]
- * Farrier –
- \$50 + \$7 gas surcharge [every 6 weeks]
- Vet fee: \$100.00 for call out + Medication
- Teeth Floating: \$150
- Call out fee to pick up animals – \$200 – \$300 + mileage
- [fee dependant on number of animals]
- * Rescues can also include goats, sheep, pigs, llamas,
- cattle and farm animals in general.
- **Approximate expenditures per year, all inclusive, for surrenders/ seizures, per year:**
- * 2014 - \$38,000
- * 2013 - \$35,000
- * 2012 - \$42,000

Minimum Standards of Care For Animals.

AS 03.55.100.

- **1)** food and water sufficient to maintain each animal in good health;
- **2)** an environment compatible with protecting and maintaining the good health and safety of the animal; and
- **3)** reasonable medical care at times and to the extent available and necessary to maintain the animal in good health.
- **b)** Any determination as to whether or not the standards of this chapter are met shall be based on the professional opinion of a veterinarian licensed under AS [08.98](#).
- **c)** The department may adopt regulations to implement this section.

- **AS 03.55.120. Seizure of Animals.**
- **AS 03.55.130. Destruction and Adoption of Animals.**
- **AS 03.55.190. Definitions.**

How Does This Work?

- **Scenario A:**

- 1) A call comes into dispatch that there could be animal neglect or abuse.
- 2) ACO or vet makes a welfare check.
- 3) “Can we help?” Provide food, water, or aid.
- 4) If help is wanted appropriate volunteers are called to help aid with feeding, caring for, or if necessary, re-homing the animal.

- **Scenario B:**

- 1) A call comes into dispatch that there could be animal neglect or abuse.
- 2) ACO or vet makes a welfare check.
- 3) Vet decides there is indeed a problem but help will not be accepted.
- 4) Trooper is asked to get a search warrant from the court.
- 5) Trooper serves warrant with a vet or ACO, if necessary, for safely taking the animal.
- 6) Vet or ACO contact caregiver for the animal.
