This is a request to allow for a sole source purchase from the following vendor:

- Liquid Springs

This is for the purchase of two Liquid Spring suspension systems. Nikiski Fire Department has had multiple failures with the current air bag system in the department's ambulances. Often when the ambulance hits a bump, the air bag system fails and the ambulance has to be taken out of service. The system has also failed when transporting a patient necessitating bringing in another ambulance to finish the patient transport. The Mechanic then has to order parts immediately to repair the ambulance and bring it back into service. The purchase of these suspension systems will rectify the current problem with the air bags that we currently have in our ambulances. I have attached a quote from Liquid Springs for \$15,758.85, which is the cost for two suspension kits that will be replaced in two of our current ambulances. Central Emergency Service is also in the process of getting the same suspension system for all their ambulances.

LiquidSpring LLC is the only vendor in the United States that has the R-4500 Class Suspension System/Kit. Anchorage Fire Department has implemented these air bag systems in their ambulances. They have reported that the systems works well and are reliable. They would recommend them for other fire departments. In the future, the department will spec out this air bag system when they purchase ambulance.
