## KENAI PENINSULA BOROUGH ORDINANCE 2016-19-01

AN ORDINANCE ACCEPTING AND APPROPRIATING GRANT FUNDS TOTALING \$19,366.00 FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES FOR THE VOLUNTEER FIRE ASSISTANCE PROGRAM ON BEHALF OF ANCHOR POINT FIRE & EMERGENCY MEDICAL SERVICE AREA AND BEAR CREEK FIRE SERVICE AREA

- WHEREAS, Anchor Point Fire & Emergency Service Area (APFEMSA) and the Bear Creek Fire Service Area (BCFSA) applied for a grant under the 2016 Volunteer Fire Assistance Program administered by the Alaska Department of Natural Resources, Division of Forestry; and
- WHEREAS, the borough received award notification, allowing the service areas to purchase wildland firefighting equipment; and
- WHEREAS, the Volunteer Fire Assistance Program requires a 10 percent match of local expenditures toward the grant funds; and
- WHEREAS, the service areas will meet the match requirement through expenditures made from their FY17 operating budget prior to December 31, 2016; and
- WHEREAS, at its regular meeting on January 20, 2016, the APFEMSA board recommended by unanimous approval the funds to meet the 10 percent match requirement; and
- WHEREAS, at its regular meeting on June 14, 2016 the BCFSA board recommended approval;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That the mayor is authorized to accept the Volunteer Fire Assistance Program grant funds from the Alaska Department of Natural Resources on behalf of Anchor Point Fire & Emergency Medical Service Area and Bear Creek Fire Service Area and is authorized to execute the grant agreements and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That APFEMSA grant funds in the amount of \$10,000 are appropriated to the account 209.51410.17VF2.49999.

**SECTION 3.** That BCFSA grant funds in the amount of \$9,366 are appropriated to the account 207.51210.17VF1.49999.

**SECTION 4.** This ordinance shall become effective immediately upon its enactment.
