We, the undersigned, certify the foregoing to be true and accurate to the best of our knowledge and belief.

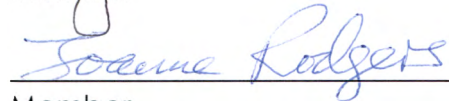

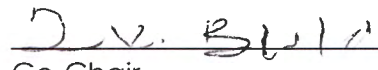

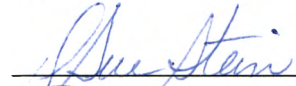
