The Purchasing and Contracting Office formally solicited and received bids for the ITB18-007 Kenai Spur Highway Extension Project No. 16NRD. Bid packets were released on May 16, 2018 and the Invitation to Bid was advertised in the Peninsula Clarion on May 16, 2018.

The project consists of furnishing all labor, materials and equipment to construct the northern extension of the Kenai Spur Highway, 8.1 miles beyond the existing pavement.

On the due date of June 26, 2018 six (6) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$4,058,993.75 was submitted by D&L Construction Co., Inc., of Cooper Landing.
