The Purchasing and Contracting Office formally solicited and received bids for ITB17-035 Bear Creek Multi-Use Facility - Exterior Surfaces and Interior Completion. Bid packets were released on April 18. 2017 and the Invitation to Bid was advertised in the Peninsula Clarion and the Alaska Dispatch News on April 18, 2017 and the Seward Journal on April 26, 2017

The project consists of replacing exterior siding and painting. Tenant improvements on 1600 square foot unfinished interior space, including: concrete, framing, drywall, drywall finishing, painting, suspended ceiling, flooring, mechanical and electrical work.

On the due date of May 10, 2017 six (6) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$171,693.00 was submitted by Harmon Construction, Inc., Seward, Alaska.
