**KENAI PENINSULA BOROUGH  
ORDINANCE 2016-19-03**

**AN ORDINANCE APPROPRIATING \$275,000 FROM THE GENERAL FUND TO  
UPDATE THE KENAI PENINSULA BOROUGH COMPREHENSIVE PLAN**

**WHEREAS**, the Kenai Peninsula Borough provides for planning on an areawide basis in accordance with AS 29.40.010; and

**WHEREAS**, the assembly is required by AS 29.40.030(b) to periodically undertake an overall review of the comprehensive plan and update the plan as necessary; and

**WHEREAS**, goal 1.1, objective 7, of the 2005 Kenai Peninsula Borough Comprehensive Plan is to regularly update the comprehensive plan to reflect changing conditions, trends, laws, regulations and policies; and

**WHEREAS**, the assembly adopted the 2005 comprehensive plan by way of Ordinance 2005-20; and

**WHEREAS**, over the past ten years the borough's population has increased by over ten percent and an update to that document would be appropriate at this time; and


**WHEREAS**, the Kenai Peninsula Borough Planning Commission at its regularly scheduled meeting of August 22, 2016 recommended approval of the comprehensive plan;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the sum of \$275,000 is appropriated from the General Fund fund balance to account number 100.21110.00000.43011, planning department contracts, to be used for consultant services for the purpose of updating the borough's comprehensive plan.

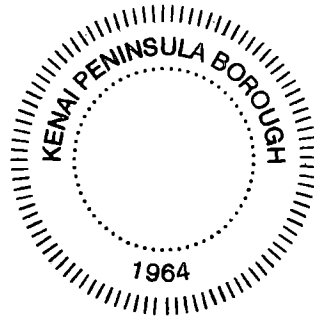
**SECTION 2.** That this ordinance takes effect immediately upon its enactment.
