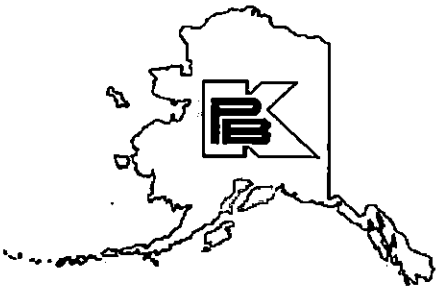

As requested, the Planning Department reviewed the Ninilchik Trading transfer liquor license application to determine if churches or schools are within 500 feet (KPB 7.10.020). A 500-foot radius search was done for KPB Parcel 157-150-36, 15945 Sterling Highway, Ninilchik.

Churches and schools are shown as institutional on the land use map. Per Kenai Peninsula Borough records, two churches and one school are within 500 feet of Parcel 157-150-36.

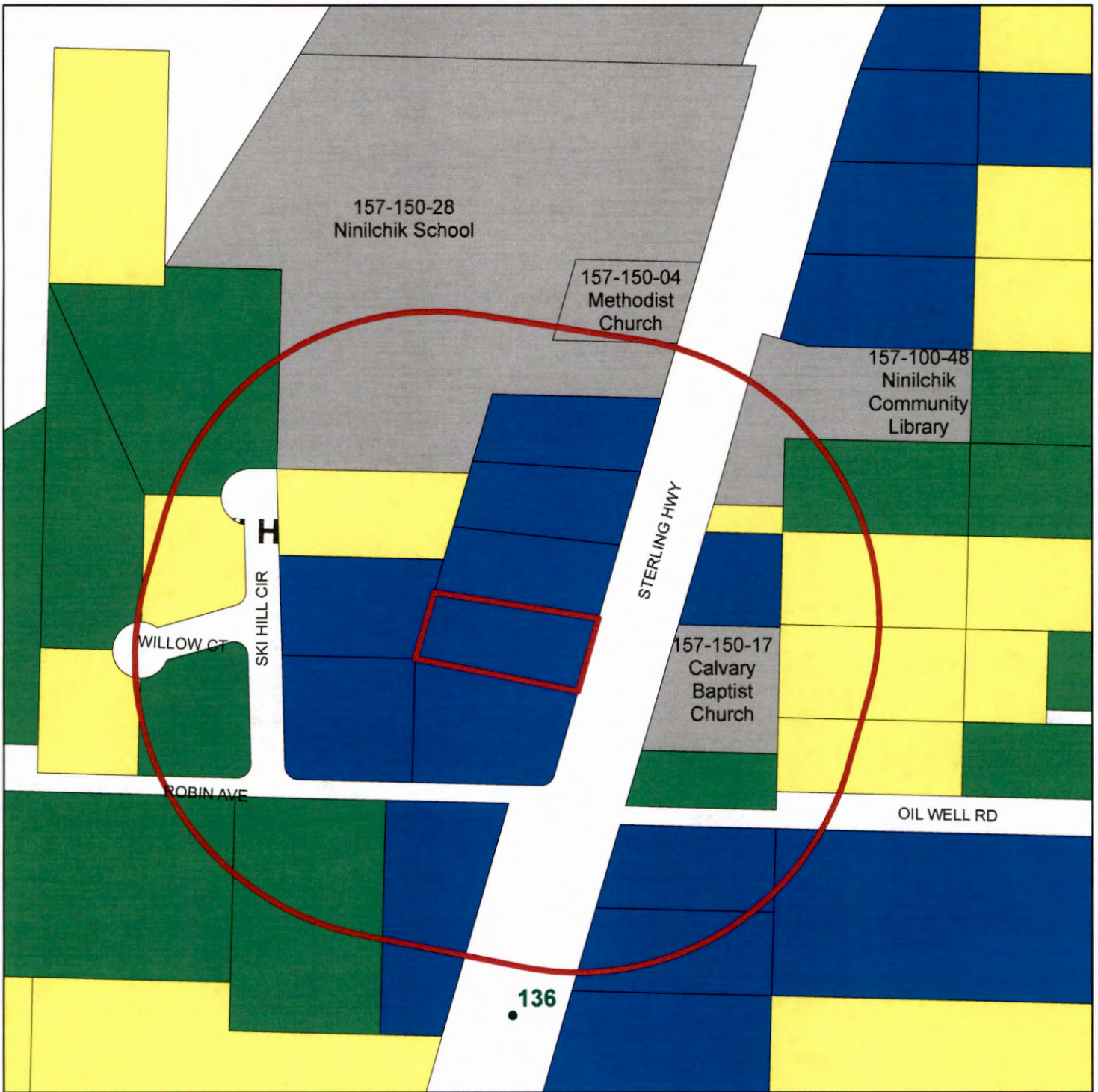

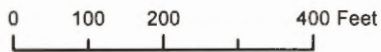

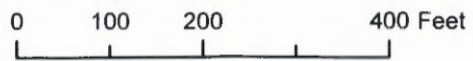

RESOLUTION 2015-21

Resolution in Support of Ninilchik Trading Co Liquor License

WHEREAS, Ninilchik Village, is a distinct, independent political community, and as such is qualified and exercises powers of self-government by reason of its original tribal sovereignty as passed down from its ancestors since time immemorial; and

WHEREAS, the Ninilchik Village Tribe is a federally Recognized Indian Tribe in Alaska (Federal Register Volume 75, Number 190, October 1, 2010, Notices Pages 60810-60814); and

WHEREAS, the Ninilchik Traditional Council (NTC) is the Tribal Governing body for the Ninilchik Village Tribe, as recognized by Ninilchik Tribal Members and the Constitution of the Tribe, with Tribal Boundaries extending from the Kasilof River through Homer, and

WHEREAS, the Ninilchik Trading Co. is proposing the procurement and implementation of a liquor license in the town of Ninilchik, and

WHEREAS, as a local government in the Ninilchik community, NTC is committed to being an active participant in our village, and cares deeply about certain negative social ramifications of alcohol consumption; and

WHEREAS, NTC strives to provide many programs which range from health and wellness, to behavioral health, social services, child welfare, environmental, housing, and resource development. In addition, specific services also include youth alcohol prevention programs and outpatient treatment services for adults, and

WHEREAS, NTC endeavors to support individuals and families in this light, especially youth alcohol prevention, however, we do not condemn the responsible legal consumption of alcohol by adults, and believe that the pursuit of another liquor license in the town of Ninilchik is reasonable and poses no adverse risk to the community, school, or local organizations, and

WHEREAS, NTC is very conscientious about alcohol consumption, the abuses that can happen from it, and the devastation that can occur when it is done illegally or to excess and we do not take additional opportunities for it to be available in the community lightly, and

WHEREAS, the community already has two liquor stores, one directly across the street from the Ninilchik School and the other in the immediate area, and

WHEREAS, we take no position as to those businesses and services or any competition created by additional business opportunities, although, we cannot find that an additional liquor store would harm the town in any way, and that it also has the potential to bring about increased tourist stops and traffic which could supplement the income of other local businesses as well.

NOW THEREFORE BE IT RESOLVED, that the Ninilchik Traditional Council (NTC) hereby supports the Ninilchik Trading Co.'s application and responsible implementation of a liquor license that would be established in conjunction with the local store and coincide with their current hours of operation.


