RE: Authorization to Award a Contract for ITB18-010 Central Peninsula Landfill C&D Disposal Area – Phase 3 Expansion

The Purchasing and Contracting Office formally solicited and received bids for the ITB18-010 Central Peninsula Landfill C&D Disposal Area – Phase 3 Expansion. Bid packets were released on February 6, 2018 and the Invitation to Bid was advertised in the Peninsula Clarion on February 6, 2018.

The project consists of clearing and grubbing of approximately 13.5 acres, stockpiling of brush in a designated area. Installation of interim Storm Water Controls including the construction of a Storm Water basin, construction of temporary perimeter ditches, and topsoil and hydro-seeding of indicated areas.

On the due date of March 1, 2018 nine (9) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$152,400.00 was submitted by Anchor Trucking, Anchor Point, Alaska.
