**KENAI PENINSULA BOROUGH  
ORDINANCE 2021-19-12**

**AN ORDINANCE APPROVING AND ACCEPTING \$4,791.02 FROM THE KENAI WATERSHED FORUM ON BEHALF OF THE DONALD E. GILMAN RIVER CENTER TO SUPPORT THE ADOPT-A-STREAM K-12 EDUCATION AND OUTREACH PROGRAM**

**WHEREAS**, the borough’s Donald E. Gilman River Center (“Center”) is a multi-agency permitting, information, and education facility that works to protect and restore the rivers and wetlands of the Kenai Peninsula; and

**WHEREAS**, the Kenai Watershed Forum’s (“Forum”) Adopt-A-Stream program is an interactive program designed to increase an understanding of watersheds through the delivery of an interdisciplinary curriculum centered on outdoor environmental experiences to K-12 students from diverse communities in the Kenai Peninsula Borough School District; and

**WHEREAS**, the partnership between Forum and the Center is a vital asset to our community that supports our children’s stewardship of our fish, wildlife, and riverine habitat across the Kenai Peninsula; and

**WHEREAS**, the Forum received a federal award from the Environmental Protection Agency Environmental Education Grant Program in support of Forum’s Adopt-A-Stream program; and

**WHEREAS**, the Forum will make a one-time payment of \$4,791.02 to the borough for educational and field trip materials in support of the Adopt-A-Stream program;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept grant funds in the amount of \$4,791.02 from the Kenai Watershed Forum to increase the Adopt-a-Stream K-12 education and outreach program, and is authorized to execute all documents deemed necessary to accept the grant.

**SECTION 2.** That funds in the amount of \$4,791.02 are appropriated to account 100.21135.22KWF.49999.

**SECTION 3.** That this ordinance takes effect immediately upon enactment.

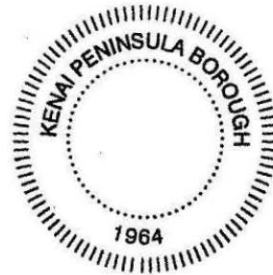
