RESOLUTION 2015-04

A RESOLUTION APPROVING COMPLETION OF PHASE III/IV OF THE MASTER PLAN FOR THE CENTRAL PENINSULA HOSPITAL IMAGING DEPARTMENT, AND THE TRANSFER OF FUNDS FROM THE PLANT REPLACEMENT FUND

- 1. WHEREAS, the Kenai Peninsula Borough has entered into a Lease and Operating Agreement with Central Peninsula General Hospital Inc. ("CPGH, Inc") for the lease and operation of Central Peninsula Hospital and other Medical Facilities, and to provide other healthcare programs and services, on a nonprofit basis to ensure continued availability to the Service Area residents; and,
- 2. WHEREAS, the Imaging department at Central Peninsula Hospital is undergoing a five phase Expansion and Remodel Master Plan to improve the department which was last renovated in the 1980's; and,
- 3. WHEREAS, Phases I and II of the Imaging Master Plan are near completion, leaving Phases III, IV, and V to be completed; and,
- 4. WHEREAS, completion of Phases III/IV of the Imaging Master Plan will allow installation of recently approved Fluoroscopy equipment into its permanent location without requiring significant down time for that service, and the project will complete the permanent space for replacement of MRI and Nuclear Medicine equipment that are nearing the end of their life cycle; and,
- 5. WHEREAS, the total projected cost for this project is \$3,134,745, which represents 8.2% of the FY14 annual gross patient revenue for Imaging Services; and,
- 6. WHEREAS, sufficient funds are available in the Central Peninsula Hospital Plant, Replacement and Expansion Fund to pay for the total projected cost of Phase III/IV of the Imaging Master Plan; and,
- 7. WHEREAS, under §13(b) of the Lease and Operating Agreement, and transfer in or out of the CPH Plant, Replacement, and Expansion Fund shall be approved by the CPGH, Inc. Board; and,
- 8. WHEREAS, CPGH Inc. Administration recommends that the CPGH Inc. Board of Directors approve the Phase III/IV Imaging Remodel Project, and approve the transfer of funds in the amount of \$3,134,745 out of the CPH Plant, Replacement and Expansion Fund to pay for this project; and,
- 9. WHEREAS, CPGH, Inc. has and shall abide by any and all conditions within 10(c) <u>Purchasing Procedures</u> of the Lease and Operating Agreement regarding contracts for the Phase III and IV Imaging Remodel Project; and,
- 10. WHEREAS, under KPB Code §5.04.11.A, a voter referendum is not required for capital improvement projects to CPH paid for by expenditures from the CPH Plant, Replacement and Expansion Fund; and,
- 11. WHEREAS, under §12(b)(iii) of the Lease and Operating Agreement, all capital improvement projects expected to exceed \$250,000 using funds not previously appropriated for that purpose must be approved by the Borough Assembly after consideration by the Service Area Board.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF DIRECTORS OF CENTRAL PENINSULA GENERAL HOSPITAL, INC., A NOT-FOR-PROFIT ALASKA CORPORATION, THAT:

SECTION 1.

The CPGH Inc. Board of Directors approves the Phase III/IV Imaging Remodel Project at the total cost of \$3,134,746, with the funds for payment to be made from the CPH Plant, Replacement and Expansion Fund.

SECTION 2.

The CPGH Inc. Board of Directors approves the transfer of \$3,134,746 from the CPG Plant, Replacement, and Expansion Fund for expenditures for the Phase III/IV Imaging Remodel Project, subject to consideration by the Service Area Board and to the approval of the Borough Assembly.

SECTION 3.

This resolution becomes effective upon its adoption by the CPGH Inc. Board of Directors.




