**KENAI PENINSULA BOROUGH  
ORDINANCE 2015-19-27**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF IMAGING EQUIPMENT  
AND ASSOCIATED SERVICE AGREEMENTS AND APPROPRIATING \$1,575,323  
FROM THE CPGH, INC. PLANT REPLACEMENT AND EXPANSION FUND**

**WHEREAS,** the Kenai Peninsula Borough has entered into a Lease and Operating Agreement with Central Peninsula General Hospital, Inc. ("CPGH, Inc.") for the lease and operation of the Central Peninsula Hospital ("CPH") and other medical facilities, to operate these Medical Facilities on a nonprofit basis in order to ensure the continued availability of the medical facilities to the service area residents and visitors; and

**WHEREAS,** as part of the hospital's Phase III and Phase IV imaging renovation project, the CPGH, Inc. Board of Directors authorized the purchase of various pieces of equipment to replace equipment that are nearing the end of their useful life; and

**WHEREAS,** nuclear medicine technology has advanced significantly since the current Philips Forte Jetstream Nuclear Medicine camera was installed in 2005; and

**WHEREAS,** CPH is proposing to replace the current Philips Forte Jetstream Nuclear Medicine Camera with a Symbia Intevo 6 SPECT/CT camera which will provide nuclear medicine studies which are more advanced, more informative, and of better diagnostic quality than the current Jetstream Nuclear Medicine camera; and

**WHEREAS,** the current Symphony TIM 1.5T MRI machine which was installed in 2004 and upgraded in 2009 is nearing its end of life and end of service; and

**WHEREAS,** CPH is proposing to replace the current Symphony TIM 1.5T MRI with an Aera 1.5T MRI, which will provide improved image quality while being easier to use for both the technologist and the patient; and

**WHEREAS,** the current MR breast coil, a 4-channel coil purchased in 2009, is not able to be used with the Aera 1.5T MRI; and

**WHEREAS,** CPH is proposing to replace the current MR breast coil with a new Invivo MR breast 16 channel coil, which offers significantly improved imaging over the current 4 channel MR breast coil; and

**WHEREAS,** the cost for the Symbia Intevo 6 SPECT/CT camera is \$830,000, the Aera 1.5T MRI is \$674,923 and the Invivo MR breast 16 channel coil is \$70,400; and

**WHEREAS,** service agreements on the above equipment which take effect after each item's manufacturer's warranty expire total \$193,933 per year; and

**WHEREAS,** at its meeting of January 28, 2016, the CPGH, Inc. Board of Directors voted to approve the purchase of the above mentioned equipment and service coverage; and

**WHEREAS,** the Central Kenai Peninsula Hospital Service Area Board, at its special meeting of March 28, 2016 recommended approval by majority consent;


**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That \$1,575,323 is appropriated from the CPH Plant Replacement and Expansion Fund to account no. 490.81110.16SPE.49999 in the amount of \$830,000, for the purchase of a Symbia Intevo 6 SPECT/CT camera, to account 490.81110.16AER.49999 in the amount of \$674,923 for the purchase of a Aera 1.5T MRI and to account 490.81110.16COI.49999 in the amount of \$70,400 for the purchase of a Invivo MR breast 16 channel coil.

**SECTION 2.** That CPGH, Inc. is authorized to purchase the equipment described in Section 1 of this ordinance and the service coverage costing \$193,933 per year for Central Peninsula Hospital operations.

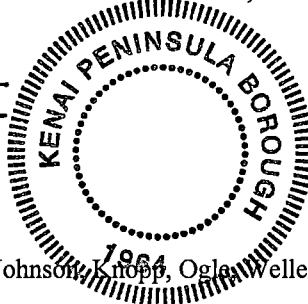
**SECTION 3.** That this ordinance takes effect immediately upon its enactment.
