WHEREAS, the Assembly finds that it is in the best interests of the Kenai Peninsula Borough to start an Opioid Settlement Fund Grant Program to distribute the funds in the manner below:

1. Given the limited number of funds, the total number of annual grants issued under this grants program will be limited to five grants, <u>unless additional grants are approved by assembly ordinance on a case-by-case basis.</u>" and

Amend Section 3 to read, "That, upon receipt of fully executed grant agreements, three additional grants may be awarded for this grant period only, up to \$34,091.72 in opioid settlement funds may be awarded to the three applicants who applied for but were not awarded funds from Round 2 of the Opioid Settlement Fund Grant Program due to the five-recipient limitation under Ordinance 2021-19-50, and as amended herein."

the borough clerk]. Upon concurrence of, and at the discretion of, the assembly president, the presentation will be scheduled for the next available meeting. The presenter must provide all presentation materials by the deadline for submitting items for the agenda set by KPB 22.40.050(C) [and state the subject of the presentation]. The borough clerk will inform the presenter of the meeting date and time. If presentation materials are not received in the Clerk's Office by the deadline, the presenter may choose between giving the presentation without materials or have the presentation removed from the agenda and rescheduled for another meeting. The total time permitted for formal presentations with prior notice concerning a subject not contained in the assembly's agenda for that meeting will be limited to ten minutes per presentation. The assembly president may, with the concurrence of a majority of the assembly, allow additional time. [Formal] [p]Presentations [UNDER THIS-SECTION before the assembly will be limited to two total presentations per regular meeting or committee of the whole meeting. [shall be limited to ten minutes per topic, regardless of the number of persons participating in the presentation. The aggregatetime for presentations with prior notice shall be 20 minutes per meeting. If the total requests received exceed 20 minutes, the clerk shall schedule the requests by giving priority based on the order the requests were received. The assembly president may, with the concurrence of a majority of the assembly, allow additional time. This timelimit shall not apply to formal presentations made at the request of the mayor or the assembly. This section does not preclude the borough clerk, with the approval of the assembly president, from scheduling presentations which will exceed ten minutes priorto the beginning of an assembly meeting or before the assembly as a committee of the whole. Any other formal presentations shall be made as approved in the agenda.]"

Assembly Member Cooper stated she appreciated the conversation regarding taxation and the borough's role as a second class borough. She stated she appreciated the work on the FY25 budget, stating it was nice and clean.

Assembly Member Ecklund thanked Brandi Harbaugh, Sean Kelley and Elizabeth Hardie for all their work on Ordinance 2024-14 and Ordinance 2024-15. She expressed her condolences for the loss of Seward's special education teacher, Joshua Green. Ms. Ecklund stated she would be attending the 06/18/24 assembly meeting via Zoom.

Vice President Cox thanked the administration and borough staff for their work on the FY25 budget. Mr. Cox stated that he believed childcare was outside the scope of a second class borough and questioned if that was the direction the borough should be headed. He congratulated Soldotna High School D2 Softball Team for receiving the academic award at the state championship. Mr. Cox reminded everyone one of Music in the Park on Wednesdays, starting June 6, 2024 6:00 - 9:00 pm.

President Johnson echoed assembly members" comments regarding the preparation of the FY25 budget. Mr. Johnson stated a special thank you to Borough Assessor Adeena Wilcox and her team for pleasant Board of Equalization hearings this year. He stated he appreciated the assembly members and the mayor for their comments and positions regarding Ordinance 2024-14 and Ordinance 2024-15.
