SUBJECT: Authorization to Award Contract for ITB17-029, 2017 CIP Alex Drive, Alex Court, Hawkins Court & Thelma Court Project No. C5ALE

The Purchasing and Contracting Office formally solicited bids for Alex Drive, Alex Court, Hawkins Court & Thelma Court Project No. C5ALE. Bid packets were released on March 29, 2017 and the invitation to bid was advertised in the Peninsula Clarion on April 4, 2017 and Homer News on April 6, 2017.

The project consists of furnishing all labor, materials and equipment to upgrade these roads. Work may include roadbed widening, embankment construction, subgrade modification, drainage, ditching and cleaning.

On the due date of April 19, 2017 five (5) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$209,745.00 was submitted by Foster Construction, LLC. The total cost for this project is \$276,943.00 which includes design services, contract services, inter-department charges, and contingencies.

This project has been approved through the Road Service Area Board at their January 24, 2017 meeting approving road projects be included as FY17 capital improvement projects.
