LTIF Allocation and Loan Analysis

Summary of Assignment

Provide Kenai Peninsula Borough with a preliminary allocation analysis and analyze the implications of providing a \$500K loan from the LTIF.

KPB Assumptions & APCM Recommendations

Initial KPB Assumptions and Investment Objectives for the LTIF:

- The LTIF's investment objectives include maximizing the LTIF's market value, maintaining a sustainable distribution rate to support LTF operations, and provide inflation protection for the principal of the LTIF.
- Per Code and the Fund Balance Policy, the LTF may not fall below \$600K in value, and amounts above \$800K may be transferred to
- Loans made by the LTIF are straight line amortized over 10 years at the prime rate (currently 5.5%)
- KPB's initial projections assumed a 6.0% annual return, 1.0% annual inflation, and a distribution rate of 5.00% of the previous year's POMV per year after three years


APCM Recommendations and Considerations:

- Currently, APCM utilizes 2.0% for the projected long-term inflation rate, which reflects the Federal Reserve's expected long-term
- Based on reasonable return assumptions, a 5.00% distribution rate and inflation protection of 2.0% would require a high (85%) equity allocation. In today's investment environment, the risk/reward trade-off for this level of equity exposure is unfavorable.
- Consider a balanced portfolio of 55% stocks and 45% bonds, which can reasonably support a distribution rate of 3.75% of the 5 year average of market values while protecting the LTIF from inflation. Distributions still begin after 3 years as initially projected.



Balanced Portfolio


The simulation indicates the portfolio is expected to grow to \$11.3MM over a 10 year horizon.

Monte Carlo simulations are valuable for planning purposes because they integrate the potential volatility associated with the portfolio. allows the Borough to assess the portfolio's ability to meet it's Returns above and below the average are incorporated, which goals in spite of market uncertainty. The wealth simulation displays 90% of the potential outcomes, which capture the return paths with the highest frequency of occurring.

At the expected case, the portfolio's value is \$11.3MM which provides for a 3.75% distribution rate and inflation protection.

Over a long term horizon, the 3.75% distribution rate would not allow for portfolio growth beyond inflation protection.

Comparison of Projections

The following table provides a summary of the key differences between KPB's initial projections and APCM's preliminary asset allocation recommendation for the first 10-year time horizon for your review.



Loan from LTIF Cost Analysis

- APCM compared \$5.6MM invested in the 55% Equity portfolio with \$5.1MM invested in the 55% Equity portfolio and a \$500K loan at 5.5% (prime) to analyze the impact to the LTIF should the Borough decide to make funding available from the LTIF.

The Kenai Peninsula Borough Maintenance department would like to purchase a replacement data collector, for the purpose of area wide rotating equipment vibration analysis, through North Coast Electric.

KPBM uses the data collector to record measurements related to preventative maintenance diagnosis and are utilized extensively in order to assure smooth equipment operation and extended life. This allows KPBM to replace expensive equipment when failure is anticipated. (predictive maintenance), rather than replacing prematurely or after unit failure. Our current unit model has reached end of life and obsolescence due to age and reliance on a no longer supported software platform. The software cannot reside on any computer system utilizing an operating system beyond Windows 7 (also no longer supported). South Peninsula Hospital provides patient care for many different acuities. It is important that staff have monitors readily available to ensure that their patients are safely taken care of. As described in their request of March 21, 2019, their monitors are 13 years old and the service agreement to repair these devices is not renewable. They do not have enough monitors to borrow, and are moving monitors from other departments to care for patients. They have three telemetry packs at present; they originally had five but due to inability to repair, two of these are out of service. Recently, the hard drive failed for the telemetry units and they were unable to transmit telemetry to the central station. They currently are leasing a hard drive while theirs is repaired.

In addition, the emergency department ("ED") has limited ability to monitor end tidal CO2 (capnography) which is now considered the standard. Replacing all 10 ED monitors will elevate their standard of care, as all monitors in the ED will be able to provide end tidal CO2. End tidal CO2 can be used to better assess patients in respiratory distress, cardiac arrest and shock which is needed for immediate assessment of critical patients.

The SPH, Inc. management obtained three quotes from three vendors offering equal quality and functionality, and GE was found to have excellent service reviews and additional training availability.

The Kenai Peninsula Borough and SPH, Inc. have entered into a sublease and operating agreement which requires authorization from the borough assembly to enter into a lease that obligates the borough for more than one year, or in excess of \$100,000. The agreement also requires that all equipment purchases in excess of \$250,000 or more, must be separately approved by the borough assembly.

At its regular meeting of March 27, 2019, the SPH, Inc. board recommended approval of this expenditure by unanimous consent. In the 2019 capital budget, South Peninsula Hospital requested replacement of its current, 13 year-olds, patient monitor system. The purchase was approved in the capital budget for FY2019. The original capital budget request was for 32 monitors, but after further consideration, the request has been increased to 33 monitors. Replacement should occur as soon as possible to ensure there is no disruption to patient care.

Since these monitors constitute a capital purchase, SPH must follow the traditional steps for submitting capital to the SPH Board of Directors, the Hospital Service Area Board, and the Assembly for approval and fund appropriation.

JUSTIFICATION:

SPH provides patient care for many different acuities. It is important that staff has monitors readily available to ensure that our patients are safely taken care of. We are short monitors to borrow, and are moving monitors from other departments to care for patients. We have 3 telemetry packs at present, we originally had 5 but due to inability to repair 2 of these are out of service. Recently, the hard drive failed for the telemetry units and we were unable to transmit telemetry to the central station. We currently are leasing a hard drive, while ours is repaired. In addition, the ED has limited ability to monitor End Tidal CO2 which is now considered the standard. Replacing all 10 Emergency Department monitors will elevate our standard of care, as all monitors in the ED will be able to provide End tidal CO2. End Tidal CO2 (Capnography) can be used to better assess patients in respiratory distress, cardiac arrest and shock which is needed for immediate assessment of critical patients.

SPH obtained a quote from GE. The company allows SPH flexibility to select monitors that fit our patient's acuity. The company has Alaska located service representatives and are willing to train our own Biomed person to learn repairs, which will prevent service calls in the future.

A RESOLUTION ENCOURAGING THE ADMINISTRATION'S EFFORTS TO FILL VACANCIES IN BOROUGH STAFF

- WHEREAS, historically the borough has consistently had a large variance between the amount of funds budgeted for the borough and the amount of funds actually spent in a fiscal year, resulting in excess funds lapsing to the general fund; and
- **WHEREAS,** the Comprehensive Annual Financial Report almost always shows the borough has done better fiscally then projected in the budget; and
- **WHEREAS,** if the assembly had wanted positions cut from borough government it would not have funded them last year; and
- WHEREAS, after Governor Dunleavy's proposed budget was released on February 13, 2019, the borough administration established a hiring freeze on all open positions in the borough along with taking other steps to decrease spending until it could identify how the state budget may impact the borough; and
- **WHEREAS,** there are currently 11 vacant positions at the borough which is increasingly impacting the remaining personnel; and
- **WHEREAS,** while the assembly recognizes the need to be prudent with borough funds in light of Governor Dunleavey's proposed substantial funding reductions to local governments, it appears the legislature may not support a large number of those reductions; and
- **WHEREAS,** a small increase to the mill rate was approved by the assembly in 2018 and the assembly and mayor have considered other revenue sources over the years; and



During the committee meeting in which this was discussed, the assembly was informed that if the borough does intervene in this matter it would be expected to split the costs of the attorneys' fees charged by Birch Horton Bittner & Cherot with the City of Homer and Kachemak City with each municipality paying one-The estimated ranges given were \$30,000 for the initial drafting and submission of the intervention and limited other work. If that does not resolve the case it is estimated that, at most, the cost would be \$100,000 for the continued representation of the municipalities through the hearing, including putting on witnesses or extensive negotiations.

This ordinance would authorize the transfer of the \$16,486.69 previously appropriated the legal department for a different RCA tariff dispute that has been resolved. Additionally, it would appropriate the sum of \$16,847 from the General Fund, fund balance for a total of \$33,333.69 in the event the full amount is needed for this matter. Any funds unspent would lapse to the General Fund upon closure of the case.

In the August 22, 2006 election, the Alaska voters approved the initiative in Ballot Measure No. 2, which imposed a tax on passengers travelling for at least 72 hours aboard a vessel with 250 or more berths, that anchors or moors in Alaska waters with the intent to allow passengers to disembark. The initiative enacted statutes AS 43.52.200 - AS 43.52.295 that provide for the levy and collection of this tax and the disposition of the proceeds. The taxes are deposited into a state fund called the Commercial Passenger Vessel ("CPV") tax account. A portion of the proceeds are disbursed to the first seven ports of call each year. If ports of call are located in a city within a borough, \$2.50 per passenger is distributed to the city and to the borough in which the city is located. Both the City of Seward and the City of Homer have qualified for these funds, and the Borough has accordingly received proceeds from the CPV account.

The tax proceeds collected for the borough have been awarded to the City of Seward and City of Homer by way of grant agreements since 2007. Each city has provided a request letter describing funding intent for eligible projects (enclosed). The cities must confirm that the use of funds will comply with State of Alaska Department of Commerce, Community & Economic Development, "Commercial Vessel Passenger Tax Program" as governed by AS 43.52.200 - 43.52.295; specifically, AS 43.52.230 (b), "shall use the funds for port facilities, harbor infrastructure, and other services provided to the commercial passenger vessels and the passengers on board those vessels."

On behalf of the community of Seward, I would like to thank the Borough Assembly and administration for allocating the Commercial Passenger Vessel (CPV) excise tax to the cities of Seward and Homer, based on their pro-rata share of cruise ship passengers visiting each port. These funds have been critical to Seward's ability to provide improvements to our port infrastructure in support of cruise ships and their passengers.

The City of Seward was asked to submit a letter requesting their allotment of 2018 cruise ship commercial passenger vessel excise tax proceeds, and to identify the intended use of these funds. AS 43.52.230(b) requires that "a city or borough that receives a payment under this subsection shall use the funds for port facilities, harbor infrastructure, and other services provided to the commercial passenger vessels and the passengers on board those vessels." Seward's planned use of these 'ports-of-call' funds will entirely meet these requirements. We have identified the following projects for utilization of CPV funds, including: 1) replacement of launch ramps in the harbor; 2) shuttle bus transportation for cruise passengers and crew, including preparation of maps showing location of bus stops; 3) ambulance services for cruise vessel responses by SVAC and SVFD; 4) cruise visitor impacts to Port Avenue and library; 5) wayfinding directional signs and information; 6) dock maintenance and repairs; and other port and harbor infrastructure needs.

We appreciate your support of our request, and look forward to working with you to enhance facilities for the cruise ship industry in our region.

I am writing to confirm that the City of Homer wishes to receive the 2018 Commercial Vessel Passenger Tax receipts from the Borough. It is our understanding that you will be sponsoring an ordinance that would make the Borough's share of these tax receipts for vessel landings in Homer available to the City. The City appreciates that and understands that the amount to be passed through for calendar year 2018 is \$35,815.

The City of Homer recognizes that these funds must be used for port and harbor improvements that directly benefit cruise ship passengers. The City agrees to comply with the provisions contained in AS 43.52.200 – 43.52.295 and former SB 256 and HB 310. It is the City's intention to apply 2018 funds from the Borough and the State to reimburse the Port and Harbor Enterprise fund for the construction of Ramp 2 restroom.

This project was recently completed (see attached images). Located at the center of the retail area on the Homer Spit and at the launching point for many recreational day trips, Ramp 2 is heavily used by cruise ship passengers when they are in port.

Using the funds in this manner has been previously approved by the Borough and the State. The City of Homer greatly appreciates the opportunity to pool these funds to be able to make meaningful improvements for passengers and leverage funds. In this project, the City's Commercial Passenger Vessel Tax funds leveraged Federal Land and Water Conservation Fund dollars for a 1:1 match. If cruise ship traffic remains constant, the City expects to have reimbursed the Enterprise for the CPV portion of Ramp 2 restroom by 2021.

- WHEREAS, Kachemak Emergency Service Area ("KESA") has the opportunity to purchase a stock unit fire apparatus tanker/pumper to replace its failing non-serviceable tanker on the west side of the service area immediately, while recognizing a substantial savings over the originally anticipated cost; and
- WHEREAS, KESA has been planning for the purchase of a tanker/pumper to replace the 1980 Spartan tanker acquired in 2009 from the City of Valdez surplus, and was proposing this purchase be appropriated through the fiscal year 2020 annual budget; and
- WHEREAS, in April, 2019 KESA received notice from the Rosenbauer America Manufacturer that a stock unit custom tanker/pumper that meets almost all of KESA's specifications had just become available for purchase and was being offered at a discount price; and
- WHEREAS, the dual feature/functionality of this unit as a tanker/pumper will replace the existing tanker and still meet the International Organization for Standardization ("ISO") requirements for maintaining KESA's Public Protection Classification rating of a five, as well as offer greater functionality and maneuverability for the area than the apparatus that would have been built and purchased through the FY2020 budget; and
- WHEREAS, KESA has negotiated with the supplier to include all necessary add-ons to this apparatus to meet the needs of KESA at no additional cost; and
- WHEREAS, the existing tanker will potentially be removed from service due to safety and inoperability in the near future, and this purchase will allow KESA to keep continuity of fire protection for the west side of the service area and maintain a lowered ISO Rating; and

Kachemak Emergency Services ("KESA") is respectfully requesting approval to sole source a Rosenbauer stock unit tanker/pumper fire apparatus.

KESA has the opportunity to immediately purchase a stock unit fire apparatus tanker/pumper to replace our failing non-serviceable tanker on the west side of our service area. The proposed purchase of the tanker would significantly shorten the lead times for the apparatus and advance its deployment in the service area by as much as one year.

KESA was in the process of planning for the purchase of a tanker/pumper to replace the 1980 Spartan Tanker acquired in 2009 from the City of Valdez surplus through the FY2020 budget process.

We have negotiated with the supplier to include all necessary add-ons to this apparatus to meet the needs of our environment and KESA operations at no additional cost.

KENAI PENINSULA BOROUGH ORDINANCE 2019-09

AN ORDINANCE AMENDING THE BOROUGH'S SALES TAX CODE TO LEVY A 12 PERCENT TAX ON TEMPORARY LODGING, EXEMPT TEMPORARY LODGING RENTALS FROM THE GENERAL SALES TAX, AND ALLOW CITIES THAT LEVY A SIMILAR SALES TAX ON TEMPORARY LODGING TO EXEMPT UP TO ONE-HALF OF THE BOROUGH'S TEMPORARY LODGING TAX, SUBJECT TO VOTER APPROVAL

- WHEREAS, the Kenai Peninsula Borough ("borough") needs to raise revenue to protect the general fund, which has been declining due to substantial losses in tax revenues due to past increases in tax exemptions, the continuing and projected large decline in state assistance to municipalities, other proposed cuts in municipal funding, and the increasing reliance on borough funding for education; and
- **WHEREAS**, the borough is currently facing a potentially severe budget deficit for FY 2020; and
- **WHEREAS,** currently 49 Alaska municipalities including cities and boroughs have a bed tax, with bed tax rates that are based on a percentage of price ranging from 4 percent to 12 percent; and
- **WHEREAS,** the Kenai Peninsula Borough and the Aleutians East Borough are the only secondclass boroughs in the state without an additional sales tax on temporary lodging; and
- **WHEREAS,** several hundred thousand visitors travel to the Kenai Peninsula each year and contribute in a large way to the area's economy but also create a large demand on public services in the borough; and
- **WHEREAS,** impacted borough services include solid waste, roads, recreational and senior citizen services, 911 and emergency services, hospital services and disaster services; and
- **WHEREAS,** while the revenue to the borough generated from this additional sales tax on temporary lodging would be used solely for educational purposes, it would also make other borough revenues available to offset these visitor costs and help maintain the fund balance; and

- **WHEREAS,** "temporary lodging" is currently defined in the borough sales tax code as "a service to provide any lodging of less than one month"; and
- **WHEREAS,** to clarify that this tax does not apply to the rental of spaces for motor homes, tents, and other similar temporary shelters not provided by the seller, and what is considered temporary lodging, the definition of "temporary lodging" is amended; and
- **WHEREAS,** a temporary lodging tax of 12 percent is estimated to generate approximately \$1,100,000 in additional revenues in FY2020 and \$4,400,000 in FY2021 and FY2022; and
- **WHEREAS,** to enable the cities to levy a similar tax and allow the tax to apply evenly throughout the borough, the ordinance exempts from the borough's 12 percent temporary lodging tax an amount equal to a similar city tax of up to one-half of the borough's temporary lodging tax; and
- WHEREAS, as this includes an increase in the sales tax rate voter approval is required; and
- **WHEREAS**, this also specifically authorizes cities to levy a temporary lodging tax to ensure the general law cities may legally do so under AS 29.45.700(a) after the borough exempts temporary lodging from its general sales tax provisions in this ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. KPB 5.18.100 is amended as follows:

5.18.100. General—Levied—Amount.

- A. There is levied by the borough a consumer's sales tax of up to 3 percent maximum rate on all retail sales, on all rents, and on all services made or rendered within the borough, measured by the gross sales price of the seller.
- B. In addition to the tax levied in paragraph A of this section, there is levied in the borough a sales tax on the rental of temporary lodging of up to 12 percent of the rental price of all such rentals within the borough, except as specifically exempted herein.
- C. In addition to the <u>sales</u> tax<u>es</u> levied by the borough, any municipality within the borough may levy a consumer's sales tax <u>and a temporary lodging tax that may be included in their general sales tax, taxed separately, <u>or both,</u> as provided by Alaska Statute which shall be reported, collected, and enforced according to the terms of this chapter.</u>

SECTION 2. That KPB 5.18.200(A) is amended by amending paragraph 22, as follows:

5.18.200. Exemptions/waivers—Exemptions.

The following classes of retail sales, services and rentals are exempt: Α.

- 22. The rental of temporary lodging shall be exempt from the borough general sales tax levied pursuant to KPB 5.18.100(A).
- **SECTION 3.** That KPB 5.18.215 is hereby enacted, as follows:

5.18.215. Exemptions/waivers—Temporary lodging within cities in the borough.

Rentals of temporary lodging within any city in the borough are exempt from the borough's temporary lodging room tax in an amount equal to a similar temporary lodging tax that is either levied separately from or included in the city's general sales tax, or both, with a maximum total exemption of one-half of the borough's temporary lodging tax.

SECTION 4. That KPB 5.18.900, Definitions, is hereby amended by amending the definition of temporary lodging as follows:

5.18.900. Definitions.

When not clearly otherwise indicated by the context, the following words and phrases, as used in this chapter, have the following meanings:

. . .

"Temporary lodging" [IS DEFINED AS] means a service to provide any structure or portion of a structure, permanent or temporary, fixed or mobile, in which a person, for money or other consideration, may obtain lodging, dwelling, or sleeping accommodations for less than one month. This term includes hotels, apartment hotels, motels, tourist homes, houses or courts, lodging houses, inns, rooming houses, hostels, trailers, bed and breakfasts, dormitories except as excluded below, and any other facility, structure, or room of whatever name where space for lodging, dwelling, or sleeping may be secured for consideration. "Room" excludes any self-contained and powered motor home or tent not provided by the seller, tent or tent space, hospital, medical clinic, sanitarium, or nursing home; or any student dormitory operated by a non-profit or public educational entity.

SECTION 5. That a ballot proposition shall be placed before borough voters at the regular election on October 1, 2019 to read as follows:

	sales tax of up to 12 percent on temporary lodging, exempts temporary lodging from the borough general sales tax, and exempts the amount of any city temporary lodging tax up to one-half of the borough's temporary lodging tax. "Temporary lodging" includes a service to provide lodging as described in the ordinance of less than one month for money or other consideration".
	Yes A "yes" vote means you approve of a borough temporary lodging tax of up to 12 percent instead of the general sales tax on temporary lodging, with an exemption for any similar tax on temporary lodging tax levied by a city on the lodging. This exemption in cities cannot exceed one-half of the borough's temporary lodging tax.
	No A "no" vote means you oppose a borough temporary lodging tax of up to 12 percent instead of the existing general sales tax on temporary lodging, with an exemption for any similar tax on temporary lodging tax levied by a city on the lodging. SECTION 6.	That Sections 5 and 6 of this ordinance shall become effective immediately upon enactment of this ordinance. RE: Ordinance 2019-09, Amending the Borough's Sales Tax Code to Levy

a 12 Percent Tax on Temporary Lodging, Exempt Temporary Lodging Rentals from the General Sales Tax, and Allow Cities that Levy a Similar Sales Tax on Temporary Lodging to Exempt up to One-Half of the Borough Temporary Lodging Tax, Subject to Voter Approval (Bagley)

Due largely to the state's current economic crisis and proposed reductions of state funds to local governments, the borough is currently facing a budgetary shortfall estimated to be substantial. Ordinances 2017-29 and 2018-24, which would have asked the voters to approve a bed tax, were defeated by the assembly in 2017 and 2018. The fiscal situation has worsened and the borough needs to close that shortfall. I propose that we pass this ordinance and submit it to the voters for consideration in the next regular election on October 1, 2019. If approved it would be effective April 1, 2020.

Currently 49 Alaska cities and boroughs have a "bed tax". The tax rates range from a low of 4 percent to a high of 12 percent. Three municipalities levy bed taxes using flat rates and Bristol Bay Borough has both a percent and a flat rate bed tax. If this ordinance is approved it would exempt temporary lodging rentals from the general sales tax rate, and instead would levy a maximum bed tax of 12 percent in the borough. It also grants an exemption in cities that levy a similar sales tax or temporary lodging tax in an amount equal to the city's tax, up to a maximum of one-half of the borough's tax. This is intended to help level the temporary lodging rates inside and outside of the cities in the borough.

These additional sales taxes would be used to support education. They would also make other revenues available for services funded by property taxes and help to sustain the general fund.

Several hundred thousand visitors travel to the Kenai Peninsula each year and while they contribute to the area's economy, they also create a large demand on public services in the borough. Examples of borough services provided to visitors include solid waste services, fire and emergency medical services, road services, hospitals, recreation services, 911 services and disaster assistance.

Your support in giving the voters a chance to vote on this would be appreciated.

- **WHEREAS,** the Nikiski Community Recreation Center ("NCRC") is a former elementary school building that is operated and budgeted by the North Peninsula Recreation Service Area ("NPRSA"); and
- **WHEREAS**, Tesoro Alaska Company LLC ("Tesoro") has inquired about renting a room within the NCRC to be used for temporary office and meeting space; and

This lease agreement (hereinafter the "Lease"), made and entered into this day of June 1, 2019, by and between the Kenai Peninsula Borough, 144 N. Binkley St, Soldotna, AK 99669, hereinafter referred to as "Lessor" and Tesoro Alaska Company LLC a Delaware limited liability company ("Tesoro"), 539 South Main Street, Findlay, Ohio 45840, hereinafter referred to as "Lessee".

1. <u>Premises</u>. Lessor, for and in consideration of the rents, covenants, and conditions hereinafter specified does hereby lease to Lessee the following property hereinafter referred to as "Premises":

- C. <u>Phone/ Network</u>. Phone and network service is the responsibility of the Lessee. Lessee shall indemnify, defend, save and hold Lessor, its elected and appointed officers, agents and employees, harmless from any and all claims, demands, suits, or liability of any nature, kind or character including costs, expenses, and attorney fees resulting from Lessee's failure to perform in accord with the terms of this Lease in any way whatsoever. The Lessee shall be responsible under this clause for any and all claims of any character resulting from Lessee or Lessee's officers, agents, employees, attorneys, suppliers, and subcontractor's acts, omissions, or failure to perform under this Lease in any way whatsoever. This defense and indemnification responsibility shall not include claims alleging acts or omissions by Lessor or its agents, which are said to have contributed to the losses, failure, violations, or damage. No assent, expressed or implied, by either party to any breach of either party's covenants shall be deemed to be a waiver of any succeeding breach of the same covenants, nor shall any forbearance by a party to seek a remedy for any breach be deemed a waiver by that party of its rights or remedies with respect to such breach.
- 12. <u>Integration</u>. This document contains the entire lease agreement of the parties hereto.
