Assembly Member Hibbert agreed with Mr. Davis' earlier comment regarding the borough employees. He thanked the borough employees and others from District 1 that attended and testified. Mr. Hibbert stated it was troubling to hear that if testifiers did not agree with the administration that they felt threatened. He wanted everyone to feel free to testify and that everyone's voice was heard. He wished everyone a good evening and to drive safe.

Assembly Member Carpenter congratulated the Seward High School cheerleaders for taking first place in the Division 2 championships. He wished everyone a good evening.

Assembly Member Bagley stated he was a product of the Kenai Peninsula Borough School District and enjoyed the testimony. He stated he was going to be supportive of school funding, maybe not the full amount requested, but pretty close. Mr. Bagley stated that the Mayor had made several comments that perhaps had inflammed the situation and was not happy that the Mayor was not in attendance to hear the testimony.

Assembly President Ogle stated he concurred, there were great employees in the borough. He discussed a couple of his suggestions regarding the state budget and generating revenue, as well as the legislature conviening every two years.

This report includes brief descriptions of pending non-routine court cases, as well as administrative appeals and code compliance enforcement actions set for hearing before the administrative hearing officer.

A. Following is a summary of the non-routine litigation in which the borough and school district are involved. This list does not include the real property tax foreclosures and numerous standard tax collection cases pursued by the borough:

1. <u>Walden v. Kenai Peninsula Borough School District</u> – Case No. 3KN-17-00741CI. A former student, Trevor Walden, brought suit against the school district for personal injuries allegedly suffered during a weightlifting class at Soldotna High School on February 25, 2015. Trial call is set for May 8, 2019 with trial scheduled for the week of May 20, 2019.

2. <u>John Does 1–3 v. Kenai Peninsula Borough School Distric</u>t – Case No. 3KN-18-00155CI. Three former students sued the school district, the Kenai Peninsula Hockey Association and former coach Bradley Elliott for damages stemming from alleged sexual abuse of minors, alleged negligent hiring and alleged vicarious liability. In April, 2018, the court granted an unopposed motion for a protective order filed by Mr. Elliott. Following court approval of a discovery stipulation, discovery is in process. The parties have filed cross-motions for summary judgment on the question of the applicable statute of limitations. Trial is currently scheduled to begin the week of April 6, 2020.

3. <u>Halstead v. Jeremy T. Anderson and Kenai Peninsula School District</u>, Case No. 3KN-18-00744CI. Plaintiff has sued Mr. Anderson and the Kenai Peninsula Borough School District for damages relating to Mr. Anderson's alleged sexual abuse of her as a minor. The complaint against the school district claims it failed to protect her from Mr. Anderson and seeks damages and actual attorney fees. The district has filed an answer and discovery is in process. The parties filed a joint notice of available trial dates requesting the court set trial for the week of May 18–22, 2020, or later, based on the court's availability. Trial has not yet been scheduled.

4. <u>Kinneen v. Kenai Peninsula Borough</u>, Case No. 3HO-18-00243CI. Mr. Kinneen filed a lawsuit to invalidate a counter permit issued by the planning department for a material site. He also requested injunctive relief to prohibit operations in the pit by permittee, Beachcomber, LLC. The borough has filed an answer and motion for summary judgment. Oral argument on the motion for summary judgment has been requested.

5. <u>Sandra Brown v. Kenai Peninsula Borough and Charlie Pierce</u>, 3KN-19-00067CI. Ms. Brown filed a lawsuit against the borough and Mayor Pierce for damages relating to alleged employment discrimination and other employment-related claims. A pretrial scheduling conference was held on March 26, 2019. The pretrial scheduling order setting the trial date and all pretrial deadlines is pending issuance by the court.

6. <u>Kane County, Utah v. The United States of America</u>, Case Nos. 17-739C; 17-1991C. This is a class action lawsuit for the underpayment of PILT funds for fiscal years 2015-2017, in which the borough is a party. The court entered judgment for the plaintiffs in the amount of \$16,322,574 on November 16, 2018 and allocated a total of \$112,175 to the borough for underpayment of PILT monies for the years of 2015 and 2016 and \$6,294 for

2017. The U.S. has filed notices of appeals of the court's judgments. The US filed for a 59-day time extension to May 17 in which to file its opening briefs. The Court of Appeals granted the government's motion on March 26, 2019.

B. Following are recently resolved or open cases for matters enforced pursuant to KPB 21.50, Violations and Enforcement, which were set for hearing before an administrative hearing officer:

1. <u>Case No. 2018-19</u>. A material site was operated in violation of its material site permit by destroying the required buffer area of the pit. An enforcement agreement was entered. Time has passed for compliance with the enforcement agreement and further enforcement action is being pursued.

C. Following are open administrative appeals from Planning Commission decisions:

1. <u>Case No. 2018-02.</u> An applicant filed an appeal from the Planning Commission's denial of a material site. The case has been briefed and heard and the hearing officer remanded the case to the Planning Commission. The matter was heard at the March 25th Planning Commission meeting and the hearing was continued until the May 28, 2019 Planning Commission meeting.

2. <u>Case No. 2018-04.</u> An appeal of an approved plat was filed and a hearing held before the administrative hearing officer on March 1, 2019. On March 20, 2019 the hearing officer issued a decision upholding the plat approval. Appellants may file an appeal to the superior court within 30 days of the decision.

AN ORDINANCE APPROVING AND APPROPRIATING GRANT FUNDS TOTALING \$23,530.89 FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES FOR THE VOLUNTEER FIRE ASSISTANCE PROGRAM ON BEHALF OF ANCHOR POINT FIRE AND EMERGENCY MEDICAL SERVICE AREA, BEAR CREEK FIRE SERVICE AREA, KACHEMAK EMERGENCY SERVICE AREA AND NIKISKI FIRE SERVICE AREA

- WHEREAS, Anchor Point Fire and Emergency Medical Service Area, Bear Creek Fire Service Area, Kachemak Emergency Service Area and the Nikiski Fire Service Area applied for individual grants under the 2019 Volunteer Fire Assistance ("VFA") program administered by the Alaska Department of Natural Resources, Division of Forestry; and
- **WHEREAS,** the borough received an award notification, allowing the service areas to purchase wildland firefighting equipment; and
- **WHEREAS,** the VFA program requires a 10 percent match of local expenditures toward the grant funds; and
- WHEREAS, the service areas will meet the 10 percent match requirement and 1 percent administration fee through expenditures made from their approved FY19 operating budget if purchases are made prior to June 30, 2019 or, from their FY20 operating budget, if purchases are made between July 1 and December 1, 2019; and
- **WHEREAS,** at its regular meeting on March 20, 2019, the Anchor Point Fire and Emergency Medical Service Area board recommended by unanimous approval to accept the grant funds; and

The overall mission of the State of Alaska Department of Commerce, Community, and Economic Development (DCCED) "Community Development Block Grant Program" (CDBG) is to enhance the quality of life for low and moderate income residents, particularly in rural Alaska. The CDBG Program, a federal pass-thru grant through the U.S. Department of Housing and Urban Development, fulfills this mission by acting upon its defined goals and objectives such as providing financial resources to communities for public facilities, planning, and special economic development activities which encourage community self-sufficiency, reduce or eliminate conditions which are detrimental to the health and safety of local residents, and reduce the costs of essential community services.

The unincorporated community of Funny River qualifies as a CDBG applicant. In the fall of 2018, the Funny River residents approved the purchase of a pumper/tanker for CES Station #5. As the number one CDBG application, the CES board of directors unanimously recommended the 25 percent cash match of \$162,500, and the assembly approved the project and cash match by way of Resolution 2018-050. The borough received award notification from DCCED approving a FY18 CDBG award of \$487,500 and the \$162,500 cash match for the purchase of a pumper/tanker. An additional \$6,500 is to be appropriated for the required administrative service fee. The proposed project start is May 2019 and the estimated delivery of and training to the pumper/tanker is November 2020. Roy Browning, CES Chief, is the project manager for this award.

AN ORDINANCE APPROPRIATING SUPPLEMENTAL FUNDING OF \$2,423,955 FOR THE KENAI PENINSULA BOROUGH SCHOOL DISTRICT FISCAL YEAR 2019 BUDGET

- WHEREAS, Governor Michael Dunleavy has submitted a proposal for fiscal year 2019 that reduces education funding statewide by approximately \$20 million and has also proposed eliminating a \$30 million one-time funding increase to school funding for fiscal year 2020; and
- WHEREAS, if the \$20 million reduction for fiscal year 2019 is approved the state will withhold about \$1,398,898 from the Kenai Peninsula Borough School District ("KPBSD") that was appropriated by the state legislature last session as one-time funding, and is included in KPBSD's current budget; and
- WHEREAS, without this cut the KPBSD is eligible for an additional \$2,423,955 in local funding for FY 2019; and
- WHEREAS, if the \$30 million decrease for fiscal year 2020 is approved the state will withhold an estimated \$2,100,012 from KPBSD in one-time funding and the state would underfund state aid under the foundation formula by \$18,857,895, which would reduce the maximum allowable local contribution by the borough to KPBSD for fiscal year 2020; and
- **WHEREAS,** the proposed state reductions in FY 2020 funding are not expected to allow any additional funds from the borough to offset state funding restrictions, but instead are likely to decrease the allowed borough contribution as well; and
- **WHEREAS,** these cuts to education funding will significantly impact the school district by requiring it to make changes including potentially closing six schools, eliminating or reducing some certified positions and many support staff positions, significantly increasing the pupil teacher ratios at all levels, and substantially reducing or eliminating extra-curricular support throughout the district; and
- WHEREAS, KPBSD has requested that the borough increase the FY19 local contribution to the maximum allowable amount of \$52,162,387 which would provide additional funding of \$2,423,955 to the school district; and

- **WHEREAS,** this would allow KPBSD to retain some of its non-tenured staff for FY20 as well as provide a needed cushion to any potential reduction in state funding for fiscal year 2020; and
- **WHEREAS,** education funding is a very high priority for the borough as the school district is an extremely important component of the Kenai Peninsula Borough economy and community lifestyle;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. The sum of \$2,423,955 is hereby appropriated from the General fund, Fund balance, to be transferred to the School Fund, account number 241.94910.50241.

SECTION 2. That this ordinance shall become effective upon its enactment.

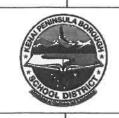

Dear Mr. Ogle:

This letter is in follow up to the joint Assembly, School Board work session conducted on March 5, 2019. During the discussion, School District administration provided information to support the necessity of maximum funding from the Borough for the FY19 Budget. As discussed, there is a strong possibility that State funding in FY20 for the School District and Borough will be substantially less than originally planned. With this in mind, it is quite possible that the proposed reductions for FY20 will not allow any additional funds from the Borough to offset State funding reductions. In fact, proposed State reductions could reduce what the Borough is allowed to fund the School District in FY20 to a level below current funding.

Maximum funding for FY19 will allow the School District to retain some of our non-tenured staff for FY20 as well as provide a cushion to any potential State funding reductions.

We are requesting funding at the maximum allowable in the amount of \$52,162,387. This would provide additional funding of \$2,423,955 for FY19.

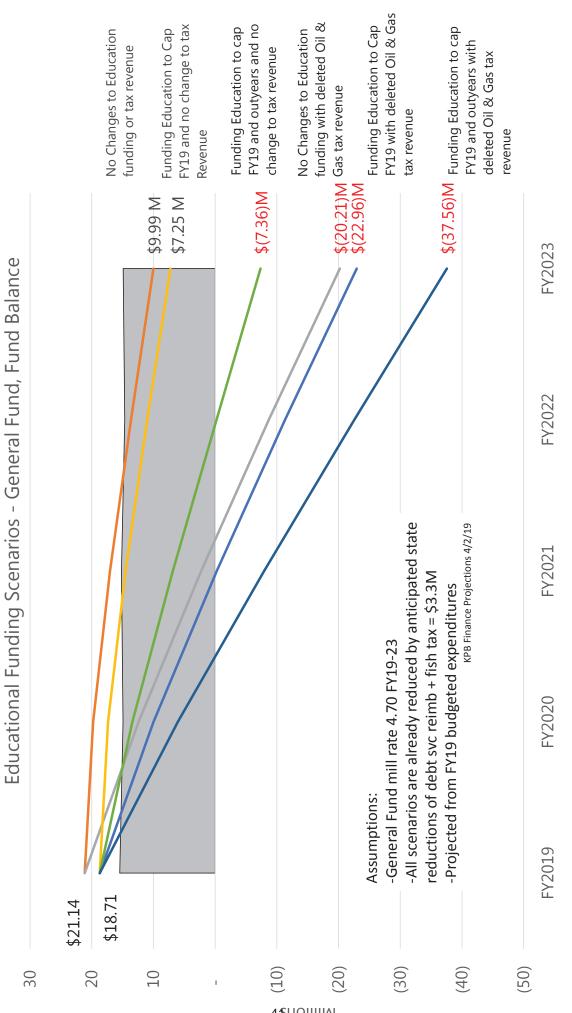

Hello, local representatives;

We have recently relocated our family back to Homer, Alaska after living in Oregon for the last 15 years. I grew up here, and something I was always very proud of was the caliber of our public schools, the active community surrounding our theater and pool (so important during these long and dark winters!), the access to vocational resources shared with the community college as high school students, and the opportunities to travel as teams and individuals throughout the state through sports. Individually these experiences ranged from routine to exceptional, but collectively they were formative. We wanted our kids to enjoy the same upbringing that I did, and so we uprooted them, our investments, basically our entire lives to allow them this experience.

The recent threat to remove so much imperative funding from our school district feels personal, yes, because of the grave impact it will have on our family. What worries me even more is the impact it will have on our community. Who would choose to raise their families here? It takes a village to nurture young people. Will educators, the educated, the artists, the athletes, the investors, the visionaries see a future for themselves or their families here? Slashing budgets so erratically jeopardizes not only our kids' immediate education (40 kids a classroom does not qualify as "education"; it actually seems like inadequate-to-the-point-of-being-dangerous-childcare), it creates a confidence crisis in all those who are paying attention to Alaska's economic future.

Already, just with the proposal of this budget slashing, teachers are looking to relocate out of our state. Positions become available for applying in March, and nobody can afford to wait to see where the dust settles on these disastrous proposals, so they're scouting new jobs in the lower 48s. The fact that we are already losing quality teachers, community members, and young families to these threats is deeply unsettling. Not only do they have no job security, as one of them put it "I don't want to raise my family in a place that puts such a low priority on education and thinks 40 kids to a classroom is realistic for learning".

We are sickened daily by the ongoing conversations that nobody can help themselves but having: A third of the high school teachers gone?! Merging our rural school to the one in town with multiple portables/ an hour-long-busride away?! Closing the pool in our seaside community- reckless endangerment!! Closing our beloved theater, the center of our cultural experiences and exposure to the endeavors local and abroad?!!

These decisions to slash our school's budget are coming hand-in-hand with similarly dire threats to our marine highway system and our state airports. Collectively they are a blatant attack on rural communities, and rural communities define the Alaskan lifestyle.

We do not have a diverse economy to support critical infrastructure, so dividends from oil revenues were designed to cover the inevitable shortfall that was predicted in order to support future generations. Why is the permanent dividend now being promised as cash payouts to Alaskans? Is it for the easy votes? This is the equivalent of some kid running for class president on the campaign platform of getting a soda machine for the lunch room. This is obviously a terribly idea, so the adults in the room have to shut it down on the grounds of tooth decay, obesity, ADHD, and diabetes. Who is the adult in the room advocating for the un-fun idea of not handing out a bunch of cash? Who has to say no to flat-screen TVs and Hawaiian vacations? Who has to remind us that entire communities will collapse if we don't have schools, airports, or a ferry system?

I'm thinking it's you. We do know better, but that cash is just so fun! But we actually aren't entitled to use it for discretionary spending. It is our responsibility to use it to invest in Alaska's future. And dismantling all of our public services does just the opposite if that. Yes, some people (as our family did growing up) use it for important bills, like heating and groceries. But these folks could instead be offered targeted programs to alleviate financial crisis. I don't think this is the letter where I advise on how to support families in need, so I'll just point out that the permanent dividend is not the answer. We have the money available to stabilize this budget. If we simply choose not to increase the dividend by double or triple, the difference will make up for the shortfall we are scrambling to recover from. A reckless administration can damage it's own reputation pretty quickly, as been recently proven by Dunleavy. As the ripple effect of his threats cascade over our landscape, please choose to be on the right side of history. Choose quality education, choose reliable transportation, choose community centers and our cultural experiences. Choose a legacy that doesn't destroy the fabric of our identity in one generation for the fleeting momentary pop of cash money. Choose to recognize the economic peril we'll all be thrust into as this infrastructure crumbles.

I think this has all served as an important reminder not to take these imperative services for granted, as they define our identity, our culture, our way of life. They are absolutely worth fighting for, sacrificing for. Please lead us in following through with our constitutional obligation to keep our schools viable, and our communities accessible.

Thanks for your patience while I meander about in my thoughts; this budget is dangerously sweeping, and it's hard to prioritize what to be most scandalized by.

Bottom line is that we need you to help us help ourselves by allowing us to invest in our future. It is oùr responsibility.

Dear Mr. Ogle:

Transmitted herein is the 2019-2020 Kenai Peninsula Borough School District Annual Budget as approved by the Board of Education at its meeting on April 1, 2019.

The total budget for all funds is \$157,507,581. The general fund request, including expenditures and transfers, is for \$145,387,469 and the special revenue fund requests for Food Service and Pupil Transportation budgets total \$12,120,112.

The revenue projection is based on flat funding from the State of Alaska and the borough contribution, funded at the maximum allowable, is requested in the amount of \$52,537,091. This would be an increase of \$2,798,659 over the current FY19 budgeted local effort total of \$49,738,432. At this funding level the school district will be able to hire elementary school counselors, reinstate the student success liaisons and curriculum supply budgets.

The funding at the State level for education has yet to be determined. At this time the FY20 budget is based on the Base Student Allocation (BSA) of \$5,930 which is the same level as FY17, FY18 and FY19. Depending upon the level of funding from the State and Local levels, cuts to the proposed budget may have to be implemented. Potential expenditure cuts discussed by the board include increase in pupil teacher ratio (PTR) at all levels, eliminate library aides and guidance/career assistants, curriculum supplies and extra-curricular travel.

A RESOLUTION AUTHORIZING THE KENAI PENINSULA BOROUGH TO INTERVENE IN THE ENSTAR NATURAL GAS COMPANY HOMER EXTENSION SURCHARGE, TARIFF REVISION MATTER NUMBER TA310-4, FILED WITH THE REGULATORY COMMISSION OF ALASKA

- **WHEREAS,** in 2013 Enstar completed construction of a 22-mile distribution pipeline which transports natural gas from Anchor Point through the City of Homer and ending on the eastern boundary of Kachemak City; and
- **WHEREAS,** a portion of the project was paid for with a State of Alaska grant obtained by the City of Homer as a contribution in aid of construction and the remainder of the extension was to be paid with a \$1.00 per Mcf Homer Extension surcharge to be applied to all gas sales and transportation service bills for gas delivered in the surcharge area until the associated costs were recovered; and
- WHEREAS, on February 6, 2019, Enstar Natural Gas Company ("Enstar") filed tariff TA310-4 with the Regulatory Commission of Alaska ("Commission") which proposed to revise the methodology for calculating the rate of return and income tax portion of the Net Total Actual Costs for the Homer Extension, effective January 1, 2019; and
- **WHEREAS,** according to Enstar the Homer Extension surcharge was not enough to cover the carrying costs on Enstar's net investment in the extension and the surcharge will not be sufficient to pay the remaining balance of the costs without changes to the surcharge amount or methodology; and
- **WHEREAS,** according to Enstar, the projected usage volumes have been significantly lower than were forecasted when the rate was established; and
- **WHEREAS,** the Enstar surcharge has not reduced the amount owed for the Contribution in Aid of Construction; and
- **WHEREAS,** there is no record that Enstar ever informed the KPB of the rapid accumulation of compounding debt which is now more than double the amount indicated to the RCA in their 2012 tariff filing; and
- **WHEREAS,** Enstar's one-page documentation of new debt allocation indicates that the debt pay-down over the first 26 months is a modest \$4,000 against a newly-stated debt of \$3,560,421; and

- **WHEREAS,** Enstar implies that the entire debt might be recovered over a 30-year period under the new formula; and
- **WHEREAS,** it appears very likely the surcharge will remain in place for far longer than 30 years and even surpass the life of the gas supplies available for distribution to the consumer; and
- **WHEREAS,** on March 22, 2019, the Commission issued an order suspending the matter, inviting the Attorney General to participate and intervention by other qualified parties; and
- WHEREAS, in its order suspending the tariff the Commission described the proposed tariff as "Enstar seeks to lower the return component from the most recent approved rate of return to the most recent approved cost of debt; recover return and taxes that Enstar asserts it has not recovered for the time period of October 2013 through December 31, 2018; amortize those return and taxes over 30 years; update the projections of Mcf sales; and extend the surcharge from an estimated 10-year life to a 30-year life" and;
- **WHEREAS,** the Commission also identified several potential issues with the tariff, "including the application of surcharge revenues, the amortization of return and taxes, and the absence of depreciation"; and
- WHEREAS, the Kenai Peninsula Borough owns and/or leases several large facilities in the impacted area including the Homer Maintenance Facility, South Peninsula Hospital, the Homer Medical Clinic, numerous other medical facilities, and five schools; and
- **WHEREAS,** estimates indicate that natural gas surcharge fees for the hospital and the associated medical facilities currently cost approximately \$24,000 per year, which equates to an additional total cost of \$720,000 for a 30-year period; and
- **WHEREAS,** the natural gas surcharge fees for the impacted schools for fiscal year 2017 cost a combined total of approximately \$23,140; and
- **PWHEREAS**, the natural gas surcharge fees for the Homer Maintenance Facility cost \$627 for fiscal year 2018; and
- **WHEREAS,** if approved it is expected that this tariff would significantly increase the long-term surcharge fees for natural gas delivery to the borough and school district facilities; and
- **WHEREAS**, the Commission's order sets April 22, 2019, as the deadline for all interested parties to file a petition to intervene as a party; and

WHEREAS, the borough's best interests would be served by participating in this proceeding to ensure that its interests are protected;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to intervene in the Enstar tariff revision designated as TA310-4 on behalf of the Kenai Peninsula Borough on or before April 22, 2019.

Surcharge Tariff TA310-4 (Cooper, Dunne)

It recently came to our attention that Enstar has filed a tariff with the Regulatory Commission of Alaska ("RCA") proposing to revise its methodology for calculating the rate of return and income tax portion of the actual costs for the Homer Extension. This relates to the 22-mile distribution pipeline that Enstar finished constructing in 2013 which transports natural gas from Anchor Point through the City of Homer to the eastern boundary of Kachemak City. While a portion of the project was paid for with an Alaska state grant obtained by the City of Homer, the remaining costs were to be paid with a surcharge in the amount of \$1.00 per Mcf until the costs were recovered.

According to a letter filed by Enstar to the RCA the Homer Extension surcharge has not been sufficient to cover the carrying costs on Enstar's net investment in the Homer Extension; and, it does not appear that it will be enough to retire the remaining balance of the costs unless the surcharge amount or methodology are changed. Enstar attributes the failure to recover the costs to the volumes used being significantly less than originally forecast. They indicate that because the surcharge receipts did not recover the carrying costs the balance of the surcharge contribution in aid of construction has increased.

However, it appears that the \$1.8 million in surcharges paid since 2013 may have gone to return and taxes instead of paying down the construction costs and that unrealized returns and taxes have compounded on a monthly basis.

To the best of our knowledge Enstar has not informed the borough of the rapid accumulation of compounding debt which is now more than double the amount indicated to the RCA in Enstar's 2012 tariff filing.

Additionally, according to the City of Homer Enstar's documentation and new debt allocation indicates that the debt paid down over the first 26 months is only \$4,000 against the newly stated debt of \$3,560,421. While Enstar suggests that the entire debt may be recovered over a 30-year period using the new formula there is a lot of concern that the surcharge will remain in place for much longer than 30 years, and could even surpass the life of gas supplies available for distribution to the consumers.

This resolution would authorize the borough to intervene in this tariff to protect its interests against these increasing costs. The RCA issued an order inviting intervention with a deadline to intervene of April 22, 2019. The borough and school district own and operate numerous facilities in the impacted area which pay significant sums in surcharges to Enstar and this tariff would directly affect those costs. Your support of this would be appreciated.

On April 2, 2019, the borough received notice from South Peninsula Hospital, Inc. ("SPH, Inc.") that its 13-year-old patient monitoring system is experiencing issues. Replacment and installation of the 33 patient monitors should occur as soon as possible to ensure there is no disruption to patient care.

South Peninsula Hospital provides patient care for many different acuities. It is important that staff have monitors readily available to ensure that their patients are safely taken care of. As described in their request of March 21, 2019, their monitors are 13 years old and the service agreement to repair these devices is not renewable. They do not have enough monitors to borrow, and are moving monitors from other departments to care for patients. They have three telemetry packs at present; they originally had five but due to inability to repair, two of these are out of service. Recently, the hard drive failed for the telemetry units and they were unable to transmit telemetry to the central station. They currently are leasing a hard drive while theirs is repaired.

In addition, the emergency department ("ED") has limited ability to monitor end tidal CO2 (capnography) which is now considered the standard. Replacing all 10 ED monitors will elevate their standard of care, as all monitors in the ED will be able to provide end tidal CO2. End tidal CO2 can be used to better assess patients in respiratory distress, cardiac arrest and shock which is needed for immediate assessment of critical patients.

The SPH, Inc. management obtained three quotes from three vendors offering equal quality and functionality, and GE was found to have excellent service reviews and additional training availability. The Kenai Peninsula Borough and SPH, Inc. have entered into a sublease and operating agreement which requires authorization from the borough assembly to enter into a lease that obligates the borough for more than one year, or in excess of \$100,000. The agreement also requires that all equipment purchases in excess of \$250,000 or more, must be separately approved by the borough assembly.

At its regular meeting of March 27, 2019, the SPH, Inc. board recommended approval of this expenditure by unanimous consent. The South Kenai Peninsula Hospital Service Area Board will hold its next regular meeting on April 11, 2019, and provide its recommendations to the assembly prior to the scheduled hearing on this ordinance.

Sufficient funds will be available in the SPH Plant Replacement and Expansion Fund to support this additional need upon approval by SPH, Inc. board of the transfer of cash on hand in excess of 90 days to the Plant Replacement and Expansion Fund. This ordinance would appropriate \$756,000 for the purchase and installation of 33 patient monitors.

In the 2019 capital budget, South Peninsula Hospital requested replacement of its current, 13 year-olds, patient monitor system. The purchase was approved in the capital budget for FY2019. The original capital budget request was for 32 monitors, but after further consideration, the request has been increased to 33 monitors. Replacement should occur as soon as possible to ensure there is no disruption to patient care.

Since these monitors constitute a capital purchase, SPH must follow the traditional steps for submitting capital to the SPH Board of Directors, the Hospital Service Area Board, and the Assembly for approval and fund appropriation.

JUSTIFICATION:

SPH provides patient care for many different acuities. It is important that staff has monitors readily available to ensure that our patients are safely taken care of. The monitors that we have are 13 years old and the service agreement to repair these devices is not renewable. We are short monitors to borrow, and are moving monitors from other departments to care for patients. We have 3 telemetry packs at present, we originally had 5 but due to inability to repair 2 of these are out of service. Recently, the hard drive failed for the telemetry units and we were unable to transmit telemetry to the central station. We currently are leasing a hard drive, while ours is repaired. In addition, the ED has limited ability to monitor End Tidal CO2 which is now considered the standard. Replacing all 10 Emergency Department monitors will elevate our standard of care, as all monitors in the ED will be able to provide End tidal CO2. End Tidal CO2 (Capnography) can be used to better assess patients in respiratory distress, cardiac arrest and shock which is needed for immediate assessment of critical patients.

SPH obtained a quote from GE. The company allows SPH flexibility to select monitors that fit our patient's acuity. The company has Alaska located service representatives and are willing to train our own Biomed person to learn repairs, which will prevent service calls in the future.

ALCOHOL SECURITY LAYOUT



This document addresses personnel and practices that will be used to prevent the transfer of alcohol across the premises boundary and the access of alcohol by a minor.

Dirty Skillet is a restaurant / eating place. It is located at 19702 Hope Highway in Hope, Alaska, and it is the restaurant for Hope Alaska's Bear Creek Lodge. Because Dirty Skillet is part of both a lodge and restaurant, some guests and employees may be under 21 years old. To prevent the transfer of alcohol from the premises boundary and to prevent the access of alcohol by a minor, we have put the following security measures in place.

Dirty Skillet is a restaurant / eating place. It is located at 19702 Hope Highway in Hope, Alaska, and it is the restaurant for Hope Alaska's Bear Creek Lodge. Churches and schools are shown as institutional on the land use map. Per KPB records, Hope School is within the 500-foot buffer.



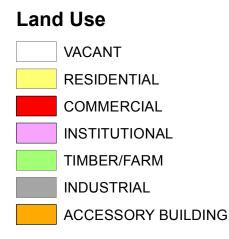

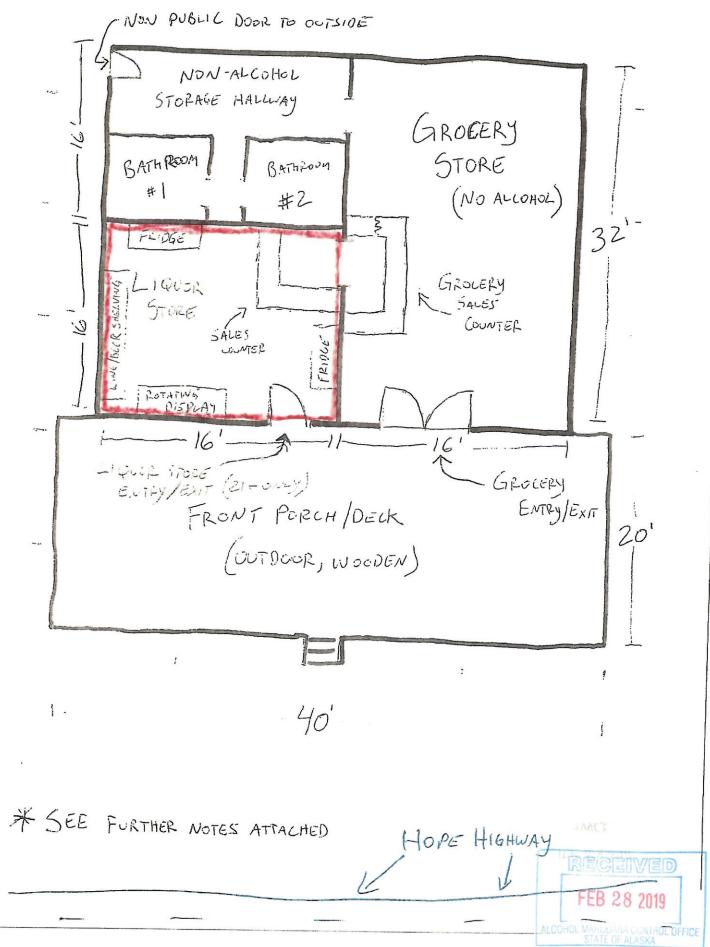

Our store in split into two sides, Left and Right. The right side will be 100% nonalcoholic, selling typical grocery/convenience store products. It has been this way for decades. The left side of our building is the Package Store licensed premises. Each "side" has its own dedicated entrance/exit. Therefore the general grocery side will be accessible to people of all ages, while the Liquor Store side will be limited to 21 and over customers only.

It is impossible for an underage person to get from the grocery store side, to the liquor store side without going back outside. No customer of any age will be able to travel between the two sides, without going outside. We modeled this layout after similar Kenai Peninsula businesses including Wildman's in Cooper Landing and the Crow Creek Mercantile in Girdwood. The Sales Counters on each side, create an island in the middle of the two sides, only accessible by employees.

Both front entrances are accessed off a large, wooden front porch/deck, that is the width of the entire building.

All alcohol being sold at the Liquor Store will be stored within the Liquor Store room in Fridges or dry storage. Only accessible to employees with valid TAPs cards.

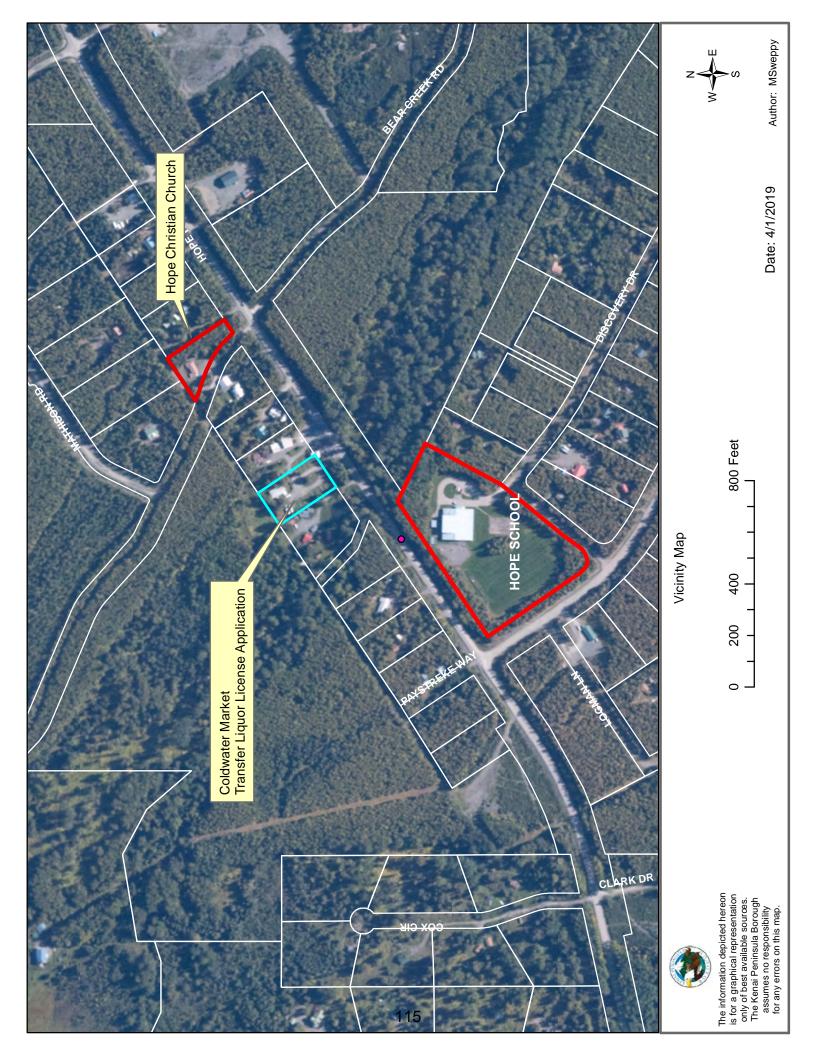

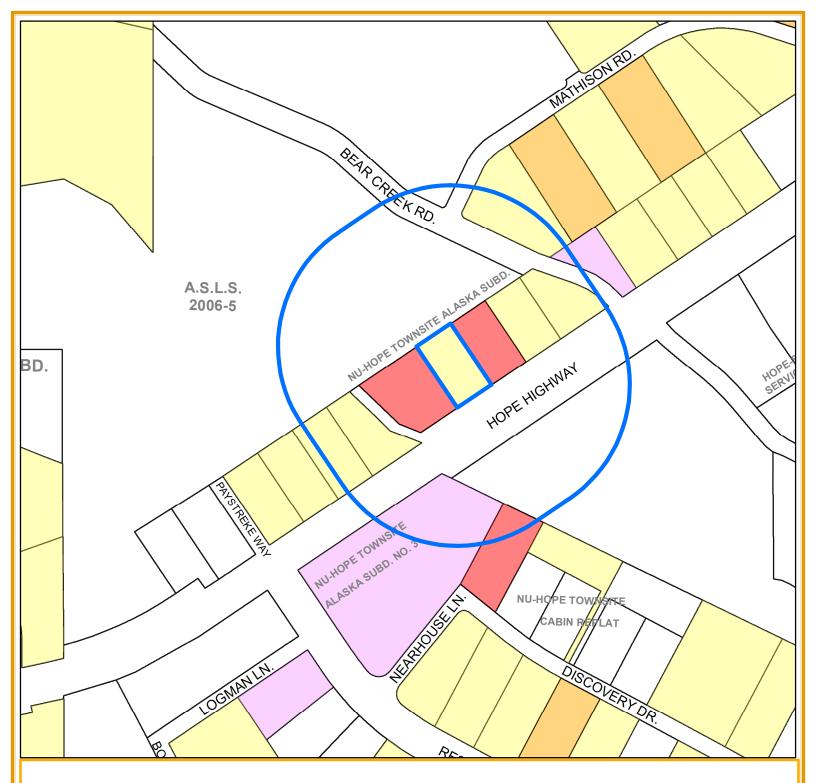
As requested, the Planning Department reviewed Coldwater Market Transfer liquor license application to determine if churches or schools are within 500 feet (KPB 7.10.020).

A 500-foot radius search was done for KPB Parcel 035-290-08, 19742 Hope Highway, Hope.

Churches and schools are shown as institutional on the land use map. Per KPB records, Hope School and Hope Christian Church are within the 500-foot buffer.

- Hope Christian Church is more than 500 feet measured by the shortest pedestrian route from the outer boundaries of the public entrance of the church building to Coldwater Market.
- Hope School is more than 500 feet from Coldwater Market measured by the shortest pedestrian route from the outer boundaries of the school ground or playground.
