RESOLUTION 2022-040**

**A RESOLUTION AUTHORIZING A SOLE SOURCE CONTRACT FOR SUMMER AND  
WINTER ROAD MAINTENANCE WITH RED MOUNTAIN, LLC FOR  
SOUTH REGION, UNIT 9**

**WHEREAS,** the Kenai Peninsula Borough (“Borough”) Road Service Area issued an invitation to bid (ITB22-043) for summer and winter road maintenance for South Region, Unit 9, located in the Seldovia area, and no bids were received; and

**WHEREAS,** the Borough’s Road Service Area has contracted with Red Mountain, LLC (a subsidiary of Seldovia Native Association, Inc.), for summer and winter road maintenance for South Region, Unit 9, located in Seldovia, since 2004; and

**WHEREAS,** the Borough currently has a contract with Red Mountain, LLC, to provide summer and winter road maintenance for the South Region, Unit 9 that expires on June 30, 2022; and

**WHEREAS,** there are limited resources for other local contractors interested and capable of providing summer and winter road maintenance for South Region, Unit 9, a remote location; and

**WHEREAS,** in the interest of saving time and effort, the Road Service Area is requesting that a sole source contract be awarded to Red Mountain, LLC, for summer and winter road maintenance in the Seldovia area; and

**WHEREAS,** funding in the amount of \$148,000.00 is proposed in the FY2023 Road Service Area budget from account number 236.33950.00000.43592 for summer and winter road maintenance; and


**WHEREAS,** the Road Service Area Board at its regularly scheduled meeting on June 14, 2022, recommended approval by the passage of RSA Resolution 2022-002;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That pursuant to KPB 5.28.580 the mayor is authorized to award a sole source contract to Red Mountain, LLC, to provide summer and winter road maintenance for South Region, Unit 9, located in Seldovia, Alaska.

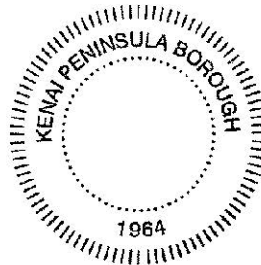
**SECTION 2.** That this resolution is effective immediately upon its adoption.
