AGREEMENT TO EXTEND THE CONTRACT For Port Graham Landfill Operations and Maintenance WITH

Windy Bay Services, LLC

On July 1, 2021, the KENAI PENINSULA BOROUGH ("KPB"), an Alaska Municipal Corporation, 144 N. Binkley Street, Soldotna, Alaska 99669, and Windy Bay Services, LLC ("Contractor"), 800 E. Dimond Blvd., Suite 3-550, Anchorage, Alaska 99518, entered into an Agreement for Port Graham Landfill Operations and Maintenance (Agreement).

Pursuant to Article 2, Time of Commencement and Completion, the parties do hereby agree to extend the period of that Agreement by one (1) year, until June 30, 2023, subject to the appropriation and availability of funds.

The contract amount will increase by the annual CPI for Anchorage Alaska. This increase will take effect March 1, 2023.

All remaining terms and conditions of the original Agreement shall remain in full force and effect. This extension document shall be controlling to the extent there is a conflict between the terms of the original Agreement, any prior extensions, and this extension.

The Kenai Peninsula Borough ("Borough") and Contractor agree as set forth below.

ARTICLE 1

THE CONTRACTOR SHALL PERFORM ALL THE WORK REQUIRED BY THE CONTRACT DOCUMENTS FOR THE PROJECT: PORT GRAHAM LANDFILL OPERATIONS AND MAINTENANCE 2021.

ARTICLE 2 TIME OF COMMENCEMENT AND COMPLETION

Work shall commence on July 1, 2021 and, subject to assembly or mayor approval and assembly appropriation, shall extend through June 30, 2022. This contract may be renewed annually upon the written agreement of the parties. This Contract is subject to appropriation of funding by the Kenai Peninsula Borough and is subject to termination and cancelation as set out in the Contract Documents. Prior to and as a condition precedent to extension, Contractor must provide a current Certificate of Insurance, current Business License, and current Tax Compliance Certificate showing full compliance with the Borough tax code.

This contract is a sole source contract authorized by Assembly Resolution 2021-039 due to lack of competition and bids during the last several bids. Should another entity open in the area, change its business model or express an interest in bidding, the Borough will once again open the formal bid process for landfill operations and maintenance in this area.

ARTICLE 11 NONASSIGNABILITY / SEVERABILITY

This Contract is not assignable. In the event any provision of this Contract or any of the Contract Documents is found to be unenforceable or void for any reason, it shall be considered severed from the Contract, and the remaining portions of the Contract Documents shall stand as if the provision had never been included in the Contract. In the event the unenforceable or void provision is legally essential to the continuing existence of the Contract, the parties shall attempt to substitute a reasonable replacement provision.

ARTICLE 12 COUNTERPARTS

This Contract may be executed in counterparts (whether by facsimile or PDF signature or otherwise), each of which when so executed shall constitute an original and all of which together shall constitute one and the same instrument.
