Assembly Member Derkevorkian congratulated Mr. Ribbens on his appointment. He expressed his disappointment of the body's actions regarding the appointment to the District 3 assembly seat, stating they were not listening to the wishes of Nikiski residents.

Assembly Member Ribbens thanked the other three candidates who applied. He stated it was humbling and an awesome opportunity to represent the residents of Nikiski. He thanked the assembly for their support of his application.

Assembly Member Chesley welcomed Mr. Ribbens to the Assembly. He thanked the other three candidates for applying. Mr. Chesley gave a brief update on fishing news, stating cod fishing season had opened and the struggles of the crab fisheries.

Assembly Member Ecklund stated the importance of the emergency radio communications getting fixed as fast as possible on the east peninsula. She thanked

the four candidates for applying to the District 3 assembly seat. She stated she too had received public comments regarding the appointment. Ms. Ecklund stated she looked at a three part process in making her selection; recommendations from the public, the interview process and the candidate's speech. She congratulated Mr. Ribben on his appointment. She thanked everyone for their testimony.

Vice President Cox echoed the same to all four candidates for applying to the District 3 seat. He welcomed Mr. Ribbens to the Assembly. He encouraged the candidates to run for election in October. Mr. Cox shared that he attended the 2023 Industry Outlook Forum, as did the four mayoral candidates, and shared a couple highlights. He shared some upcoming athletic events for Soldotna High School. He wished everyone a good evening.

President Johnson acknowledged and noted a few noteworthy individuals; School Board President Debbie Cary, Former Assembly President Wayne Ogle, Mayoral Candidate Linda Hutchings, and Mayoral Candidate Dr. Zachary Hamilton. Mr. Johnson shared that he too received public comment regarding the assembly appointment and stated that was not the only factor in his decision making process. He congratulated Mr. Ribbens for his appointment. He reminded everyone to drive safely and have a good evening.
