

Creating jobs

Legalizing and regulating marijuana will bring the nation's largest cash crop under the rule of law. This will create jobs and economic opportunities in the formal economy instead of the illicit market.

Oppose

Five reasons I oppose this ordinance:

- 1. Revenue from the sale of cannabis would be helpful for the Kenai Peninsula Borough. It will be and has been exchanged for decades in the KPB and the KPB has not benefitted from the exchange in an official capacity at all. By allowing the operation of commercial marijuana establishments, the KPB would be gaining something rather than losing something.
- 2. Cannabis users are not inherently violent, destructive, harmful or illicit in any way. The prohibition of cannabis however, has created a number of problems. By allowing for legal exchange, the Kenai Peninsula Borough would be taking a step to decrease the number of problems that have arisen due to the black market exchange of cannabis.
- 3. I believe that the voters have already spoken on this issue, and that the majority of the voters in the borough do not want the borough to prohibit the operation of commercial marijuana establishments. Therefore a vote on this issue would be redundant and unnecessary.
- 4. I believe that by allowing for the operation of commercial cannabis establishments, the KPB would be taking a progressive step that other states, counties, cities and boroughs could look toward and model in the future.
- 5. There has been a growing agricultural movement on the Kenai Peninsula and there is great promise in the area of hemp production. This should not be thwarted.
