Public notice is hereby given that the Kenai Peninsula Borough has been notified of an application for a limited marijuana cultivation facility license in the **Nikiski** area. The Borough will hold a public hearing prior to providing comments to the State on this application. This notice is being sent to landowners located within a 300-foot radius of the subject property.
