Proposed Land Use: The applicant wishes to obtain a license from the Alaska Marijuana Control Board for limited marijuana cultivation on the parcel listed above.


Applicable Code: State marijuana applications are reviewed by the borough in accordance with KPB 7.20 and 7.30. State regulations (3 AAC 306) allow local jurisdictions to protest the issuance of marijuana licenses and recommend conditions to be placed upon licenses.

Public Hearing: A hearing will be held by the Kenai Peninsula Borough Planning Commission to consider the application on **Monday, June 13, 2016**, commencing at 7:30 p.m., or as soon thereafter as business permits. The meeting will be held in the assembly chambers of the borough administration building located at 144 N. Binkley Street, Soldotna, Alaska.
