I am writing to object to the above referenced USAD. I am the owner of three contiguous parcels on Moonshine Drive.

I do not believe that there is any necessity or benefit for the proposed natural gas line along Funny River Road. All occupied properties currently have sources of fueling their properties. The cost to retrofit and replace and remove our current fuel lines, fuel receptacles and appliances, as well as the assessment, will negate any potential savings on natural gas. Also, we have no way of predicting the future cost of natural gas; it may well be more expensive than our current methods of heating our homes.

I ask you to decline this USAD as unnecessary.
