The Kenai Peninsula Borough Planning Commission reviewed the subject ordinance during their regularly scheduled June 27, 2016 meeting.

#### PC Meeting: 6/27/16

"Envision Soldotna 2030" was adopted by the Kenai Peninsula Borough Assembly on April 5, 2011, as the comprehensive plan for that area of the borough within the boundaries of the City of Soldotna. Goal 1.1, Objective 7, of the 2005 KPB Comprehensive Plan is to regularly update the Comprehensive Plan to reflect changing conditions, trends, laws, regulations and policies within the borough.

Alaska statutes chapter 29.40 describes the comprehensive plan as a compilation of policy statements, goals, standards, and other planning documents such as transportation plans, community facilities plans, and land use plans to be used for the systematic and organized development of the borough. These plans will provide significant guidance to the city in the future development of their transportation and community facilities.

The plans being adopted by this ordinance were prepared by the City of Soldotna without financial assistance from the borough. The adoption of these plans is important to the city to support requests for funds or grants from the state or other funding sources.

### END OF MEMORNADUM & STAFF REPORT

Chairman Martin opened the meeting for public comment.

1. John Czarnezki, City of Soldotna Planner

Mr. Czarnezki thanked the Commission for considering this ordinance. The City Council and City Planning & Zoning Commission has formally adopted these plans. They are now seeking the Borough's approval to incorporate those plans into the Borough Comprehensive Plan as required by Borough Code and State Statutes. Most recently they have adopted a Utility Plan and a Streets Management Plan. In the past two years, they have adopted a couple of other plans including a Downtown Improvement Plan and Safe Route to School Plan. All of those with the Commission's and Assembly's approval would be rolled into their Comprehensive Plan which will allow them to pursue grants and will fold into their comprehensive plan and the general guidelines that it provides. He was available to answer guestions.

Chairman Martin asked if there were questions for Mr. Czarnezki. Hearing none the public hearing continued.

Seeing and hearing no one else wishing to speak Chairman Martin closed the public comment period and opened discussion among the Commission.
