SUBJECT: Authorization to Award Contract for ITB16-045, 2016 CIP Vincent St., Williwa St. and Cocklin Ave. Project No. W1VIN

On June 30, 2016 the Kenai Peninsula Borough Road Service Area formally solicited bids for Vincent St., Williwa St. and Cocklin Ave. for Capital Improvement Project No. W1VIN for completion in September 2016. The invitation to bid was advertised in the Peninsula Clarion on June 15, 2016.

On the due date of June 30, 2016 six (6) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. Attached is a copy of the bid tabulation sheet.

The lowest responsive bid was received from Chumley's, Inc. in the amount of \$224,284.34. The total cost for this project is \$301,297.00 which includes design services, contract services, inter-department charges, and contingencies.

The Kenai Peninsula Borough Assembly approved through Fiscal Year 2016 Budget Vincent St., Williwa St. and Cocklin Ave. No. W1VIN Capital Improvement Project. This project has been approved through Road Service Area Resolution 2015-11 Approving Road Projects Be Included as Fiscal Year 2016 Capital Improvement Projects. Expenditures for the contract will be charged to account number 434.33950.W1VIN.49999.
