Dear Honorable Assembly Members:

My name is Ivan Z. Encelewski and I am a lifelong resident of the Kenai Peninsula Borough (KPB). My permanent residence is approximately eight miles north of Ninilchik. I am intimately familiar with the Ninilchik Community, both on a personal and professional level. Specifically, I wish to bring to your attention my vehement opposition to Ordinance 2016-22. This ordinance would affect the common boundary line for the South Peninsula Hospital (SPH) and Central Peninsula Hospital (CPH) service areas. In addition, I now understand the proponent of this ordinance has signaled on multiple occasions a desire to further amend the common boundary.

As someone in the community that relies on the Ninilchik Traditional Council Community Clinic (NTCCC) for my primary medical care 1 do not want to see an amendment to the current service area. My concern is that moving the common boundary could potentially affect the vital aspects of my direct medical care by losing services at the NTCCC. The NTCCC relies on the SPH to provide a partnership for doctors, lab services, x-rays and ultrasounds. As part of this relationship between NTCCC and SPH, we now have access to Dr. Spencer. She is an absolute blessing to the community. Any potential loss of her services would be catastrophic to my family and to our people who have developed a vital bond. Regardless of the boundary change and if it were to keep the NTCCC in the SPH service area, it would directly correlate to a negative monetary impact on the SPH, thus potentially adversely impacting our community as a whole.

I am also concerned that the apparent approach of implementing this ordinance is one in which it keeps changing with regard to the ultimate boundary line. This shooting from the hip so to speak epitomizes the definition of arbitrary and capricious. It is certainly understandable that even some of my neighbors have provided comment or testimony is support of this ordinance. Some of them do generally utilize the CPH, while others like me use SPH. I can certainly understand those who may be motivated by which hospital they generally use, coupled with the potential for monetary savings, however, creating a further divide with SPH and CPH against one another is not productive. As an example, I have only used the SPH and the Alaska Native Medical Center in Anchorage for surgeries in the past 20 plus years. Family members of mine who live just north of the Ninilchik River have also utilized the SPH for urgent care needs, including surgery.

I believe that this matter should be dealt with in a cautioned approach, where all residents fully understand the impacts, and one that provides for cohesiveness not divisiveness. I also recommend consideration in the future of a more unified vision by entertaining a mill rate which doesn't have varying rates for SPH and CPH. An ordinance whereby all residents pay alike and neither hospital gains or loses is much more palatable, not one in which an arbitrary boundary has the effect of splitting Ninilchik in half. Thank you very much for your consideration of my comments on behalf of myself and my family.

I would like to voice my opposition the proposed Ordinance 2016-22 that would change the service area for Central Peninsula General Hospital. I've been following the scattered approach of this proposal and need to voice my concern.

My husband and I have lived in Alaska for 20+ years and seven miles south of Ninilchik has been our home all of these years. We have built our home and raised our children here. All three children continue to live in Ninilchik and have their own residences.

Since we moved here, my family has received primary care at the Ninilchik Clinic as well as benefiting services from both South Peninsula and Central Peninsula Hospitals. Visits to Anchorage Doctors have been necessary also.

We have seen many changes throughout the years here at the Ninilchik clinic. At first the clinic was primarily for Indian Health Services, however it expanded its services to the general public. This was an amazing benefit to our family, as driving to Homer or Soldotna during the winter or busy summer months proved to be time consuming and costly. The medical providers that have been available at the Ninilchik clinic have mainly been Nurse Practitioners and Physician Assistants until a few years ago when the clinic brought on Medical Doctors. Dr. Spencer and Dr. Downey have been absolutely awesome. Without going into personal health challenges that my husband and I experience, I will just say that by having the Medical Doctors at our local clinic has saved us, not only time and money from going to Anchorage, but peace of mind. The many services that the Ninilchik Clinic provide have been expanded and improved throughout the years because of their relations in business with South Peninsula Hospital. If adopted, this proposal would cause a loss of funding to South Peninsula Hospital which in turn would affect the Ninilchik Clinic and my family members directly.

This is why I sincerely hope that Ordinance 2016-22 is not adopted.

I appreciate your time on the Assembly and know that you speak for Homer. I have been a resident of Homer in 1972 through most of 1983 when I moved to Fairbanks. I have returned to Homer since 2004 - recent residency is 2004-2016. I have volunteered at the hospital in Homer in 1972 (when the Anchorage doctors would come here for surgery day and volunteers from the community would wash the surgery sheets and blankets after each surgery and do the dishes (no automatic dishwasher) for the staff and patients. We were taught to take blood pressures and generally keep an eye on patients during their stay. Our hospital grew from 2 beds to a few more beds and one crib to 9 beds and finally to today's special rooms and additions. We have update equipment and the best friendly caring atmosphere in our outreach. I am a member of the hospital auxiliary.

I am concerned about the Assembly decisions! **Every new month there is something about our hospital!** The one I am concerned about right now is Ordinance 2016-22 - service area **boundary lines.** I am totally against your plans as an Assembly making a decision about the line change. Our own Homer people cannot even vote!!

Our hospital serves Anchor Point. Anchor Point is listed as the most poverished White community (non native) in Alaska!! Our hospital will take care of anyone who enters its doors! This counts in today's world when we think of money and me instead of serving our people with dignity and care no matter our sacrifice. Poorer economical areas have more people without the funds to pay hospital bills. they want to pay. They want their loved ones taken care of. Some try to pay in dribbles; a few dollars every month. They are not on commercial plans or with money in their pockets. As a Homer member, please consider this! It has taken years, but we now have a staff of doctors to meet almost every need including those doctors who serve in emergency room. We have excellent equipment! We are concerned for Ninilchik and have helped its dispensary and clinic there.

To move the boundary lines will mean loss of staff, services, and huge debts because of the loss from \$200,000 to \$500,000 dollars a year. Fight for us, please.

SPH is depending on both of you most of all. This is not only a money issue, but an outreach of love. Which shall be the top priority? My son, Dr. Matthew Wise, M.D., worked emergency room week after week after week because we had fewer doctors when he worked here in Homer. He assisted in surgery. And then SPH grew some more. Now we have a troop of doctors who love being in Homer. Be thankful that you do not have to fly to Soldotna or to Anchorage everytime you need surgery or follow up. You can be surrounded by your family and friends instead of hoping they will come to visit you in faraway places.

Concerning your proposed changes to the Common Boundary between Central Kenai Peninsula Hospital Services and South Kenai Peninsula Hospital Services.

First of all, contrary to Brent Johnson's contention, it is a longer distance from Ninilchik to Central Peninsula Hospital than it is from Ninilchik to South Peninsula Hospital. Here are some stats:

1) In 2014 SPH treated 245 discrete residents from Clam Gulch and Ninilchik in its Homer facilities on 939 separate visits.

2) In FY 2015 SPH treated 250 discrete residents from Clam Gulch and Ninilchik in its Homer facilities on 917 separate visits.

3) In the first ten months of FY 2016, SPH treated 278 residents from Clam Gulch and Ninilchik in its Homer facilities on 911 separate visits.

Secondly, the residents of the southern boundary will not even have a say in this matter. Where does Kenai and Soldotna get off thinking they can make this determination for them? This is just a money grab by the central seat of power on the peninsula, as usual. If the residents along the southern boundary desire to be moved into Central Services, then it should be up to them, not anyone else.

Third, it will not reduce taxes for the residents affected for many years to come because of bonded indebtedness.

Ninilchik residents have been enjoying expanded services from SPH in their area over the last few years. These expanded services will go away if the boundaries are changed.

Lastly, Dr. Spence's efforts to provide addiction medicine clinics for the southern Kenai Peninsula will no doubt be negatively impacted.

This boundary change makes no sense for any reasonable thinking individual. In fact, if anything should be changed, the southern boundary should be moved closer to Soldotna, since this boundary splits some parts of Ninilchik. So, in this light, I would propose the boundary change be moved north, so that all of Ninilchik is part of the South Kenai Peninsula Hospital Services Area.

As a practitioner at South Peninsula Hospital for the last 35 years I would like to suggest that any decisions on Health care, service areas and hospital boundaries not be made on a random case-by-case basis. rather, it should await a consolidated health plan that I hope to see come from the Mayor's Task force.

There is no doubt that if I lived north of Ninilchik I would also want to be taxed for the hopsital that I used, independent of any difference in the mill rate. However, it is critical that we all support our hospitals, as we all support our schools.
