My name is David Groesbeck and I live at 67513 Agusta Lane in Homer.

I am concerned that the Assembly is considering a proposal to re-draw the common boundary between the Central Peninsula Hospital Service Area and the South Peninsula Service Area resulting in a significant loss of revenue to the SPH Capital Budget that is necessary to provide quality care locally to residents of the southern portion of the Borough.

It is important to note that residents from Clam Gulch and Ninilchik, who are impacted by any shift in the service area boundary, will continue to be obligated to the bond debt incurred previously by the service area.

SPH has served, and continues to serve residents of Clam Gulch and Ninilchik. It is important to note that the number of patients continues to grow.

In FY'14 SPH treated 245 residents from Ninilchik and Clam Gulch on 939 separate visits.

In FY'15, SPH treated 250 residents on 917 separate visits.

In the first 10 months of FY'16, SPH treated 278 residents in its Homer facilities on 911 separate visits.

SPH is a first rate hospital that is approaching 21<sup>st</sup> Century standards. The proposed initiative to move the service area boundary south will jeopardize our hospital's ability to continue to meet the challenges that the changing healthcare landscape poses to our hospital and borough residents in the South.

I urge you to oppose Ordinance 2016-22 by voting no.

Dear Members,

Please accept this opposition statement to the proposed Common Service Boundary Move (Ordinance 2016-22) between SPH and CPGH.

I echo and fully support Dr. Spencer, Dr. Flipeck and Dr. Smith's opposition statements.

It has been the hard work and determination of many individuals, both here at SPH, and at Ninilchik Clinic to establish a partnership for excellent care for the Ninilchik service community. There many people are able to receive care who would otherwise might not have access to excellent medical care.

The proposed boundary move has the following negative consequences:

---Most of the proposed boundary line locations run through some part of Ninilchik and would cause an unnecessary divide within the town and split the community based on new geographic lines.

---The new proposed lines would cause a major reduction in the SPH capital budget. Without appropriate funds, it is much more difficult for people to receive local care, updating equipment and improving quality, recruiting and retention of providers may all be in jeopardy.

---The services provided by Dr. Sarah Spencer with her specialty in addiction treatment are crucial as has been identified in community health assessments. Changes with the boundaries may affect the clinics she offers for the south Kenai Peninsula as the relationship with the clinic is crucially linked to SPH.

---We see a large number of patients from the Ninilchik area both at the clinic and in the hospital. This new proposal may make them feel like they are not seen as valued.

---The new proposal is not even going to be voted on by residents who will be negatively impacted by a reduction in tax support. Soldatna and Kenai residents are the ones who vote on it.

Please place on-going value on the established excellent care and established partnership between Ninilchik Tribal Clinic and South Peninsula Hospital, by opposing this proposal.
