KENAI PENINSULA BOROUGH ORDINANCE 2015-19-36

AN ORDINANCE TO RECORD EXPENDITURES OF \$1,192,674.66 PAID BY THE STATE OF ALASKA DEPARTMENT OF ADMINISTRATION, DIVISION OF RETIREMENT AND BENEFITS ON BEHALF OF THE KENAI PENINSULA BOROUGH TOWARD THE BOROUGH'S UNFUNDED PERS LIABILITY

- WHEREAS, the 2015 Alaska Legislature enacted HB2001 which appropriated funds to the Department of Administration, Division of Retirement and Benefits on behalf of the Kenai Peninsula Borough, to reduce the liability of political subdivisions to the Public Employees Retirement System (PERS) for FY2016; and
- WHEREAS, the borough was notified on August 11, 2016, that the amount received by the Department of Administration, Division of Retirement and Benefits on behalf of the borough was \$1,192,674.66, an amount estimated to be equal to the difference between the borough's budgeted PERS rate of 22 percent and a total contribution rate of 5.19 percent; and
- WHEREAS, Generally Accepted Accounting Principals (GAAP) require the borough to record expenditures paid on its behalf; and
- WHEREAS, FY2016 expenditure budgets should be increased (for which there will be a corresponding revenue adjustment) to reflect the receipt of these funds by the Department of Administration, Division of Retirement & Benefits on behalf of the borough;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That FY2016 revenue budgets are increased by the following amounts to reflect funds the Department of Administration, Division of Retirement & Benefits received on behalf of the Kenai Peninsula Borough:
