**A RESOLUTION ACCEPTING EMERGENCY RESPONSE EQUIPMENT AND  
ELECTRONIC READER BOARD FROM BEAR CREEK VOLUNTEER FIRE &  
EMERGENCY SERVICES, INC. ON BEHALF OF BEAR CREEK FIRE  
SERVICE AREA**

- WHEREAS,** Bear Creek Volunteer Fire & Emergency Services, Inc. is the qualified nonprofit entity eligible to receive the State of Alaska Community Revenue Sharing program funds for qualified unincorporated communities ("nonprofit"); and
- WHEREAS,** for fiscal years 2010, 2011 and 2015, the nonprofit has used these funds to purchase emergency response equipment to be used during responses in conjunction with the Bear Creek Fire Service Area ("service area"); and
- WHEREAS,** for fiscal year 2016, the nonprofit used these funds to purchase and install an electronic reader board onto the service area property; and
- WHEREAS,** public notifications were posted and public meetings were held to discuss and approve the use of funds to purchase the response equipment and electronic reader board for the public benefit of area residents; and
- WHEREAS,** at the public meeting held September 25, 2015, the nonprofit requested approval from the community to use the fiscal year 2016 Community Revenue Sharing funds to purchase, install and donate an electronic reader board to the service area; and
- WHEREAS,** at its regularly scheduled meeting held February 9, 2016 the service area board unanimously recommended approval to accept the response equipment from the nonprofit; and
- WHEREAS,** at its regularly scheduled meeting held June 14, 2016, the service area board unanimously recommended approval to accept an installed electronic reader board from the nonprofit; and
- WHEREAS,** on June 29, 2016 the borough entered into a memorandum of agreement with the nonprofit on behalf of the service area to oversee the installation of an electronic reader board onto the service area property; and

**WHEREAS,** it is in the best interest of the borough to accept the response equipment and electronic reader board from the nonprofit on behalf of the service area;

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**





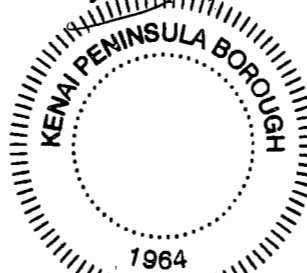
**SECTION 2.** This resolution shall become effective immediately upon adoption.
