## KENAI PENINSULA BÖRÖÜGH ORDINANCE 2016-42

## AN ORDINANCE ADOPTING IMAGINE KENAI 2030 AS THE OFFICIAL COMPREHENSIVE PLAN FOR THAT PORTION OF THE BOROUGH WITHIN THE BOUNDARIES OF THE CITY OF KENAI

- WHEREAS, the Kenai Peninsula Borough provides for planning on an areawide basis in accordance with AS 29.40; and
- WHEREAS, in accordance with KPB 21.01.025(E), cities requesting extensive comprehensive plan amendments may recommend to the Kenai Peninsula Borough Planning Commission a change to the comprehensive plan; and
- WHEREAS, with the completion of Imagine Kenai 2030, the City of Kenai has prepared extensive comprehensive plan amendments for that area of the Borough within the boundaries of Kenai; and
- WHEREAS, the revised comprehensive plan was created with extensive public outreach and participation including town hall meetings, agency outreach, meetings with business leaders and a Facebook page; and
- WHEREAS, the planning and zoning commission and the planning staff of the City of Kenai have received numerous comments and input regarding the updating of the comprehensive plan; and
- whereas, the revised comprehensive plan is a compilation of goals, objectives, and maps for guiding the physical, social, and economic development, both private and public of the City of Kenai; and
- WHEREAS, the planning commission of the City of Kenai held a public hearing on July 13, 2016 and unanimously recommended that the council of the City of Kenai approve the revised comprehensive plan; and
- whereas, the council of the City of Kenai held a public hearing on August 3, 2016, and reviewed the final draft of the revised comprehensive plan and recommended approval of the plan to the Kenai Peninsula Borough; and

- WHEREAS, Goal 1.1, Objective 7, of the 2005 Kenai Peninsula Borough Comprehensive Plan is to regularly update the comprehensive plan to reflect changing conditions, trends, laws, regulations and policies; and
- WHEREAS, AS 29.40.030(b) states that the assembly shall, after receiving the recommendations of the planning commission, periodically undertake a review of the comprehensive plan and update the plan as necessary; and
- whereas, the Kenai Peninsula Borough Planning Commission at its regularly scheduled meeting of November 28, 2016 recommended approval by unanimous consent of the revised comprehensive plan;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That the assembly adopts Imagine Kenai 2030 as the official comprehensive plan for that portion of the Kenai Peninsula Borough within the boundaries of the City of Kenai
- **SECTION 2.** That KPB 2.56.040 is hereby amended as follows:

2.56.070. Kenai comprehensive plan adopted.

The assembly adopts [THE "CITY OF KENAI COMPREHENSIVE PLAN] <u>Imagine Kenai 2030</u> [PREPARED BY THE CITY OF KENAI AND APPROVED BY THE KENAI CITY COUNCIL BY ORDINANCE 2009-2003 ON NOVEMBER 5, 2003] <u>dated January 3, 2017</u>, as the official borough comprehensive plan for that portion of the borough within the boundaries of the City of Kenai.

**SECTION 3.** That this ordinance takes effect immediately upon its enactment.
