KENAI PENINSULA BOROUGH ORDINANCE 2016-19-21

AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM THE STATE OF ALASKA DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT IN THE AMOUNT OF \$66,853.30 FOR THE ASPEN AVENUE PAVING PROJECT IN NINILCHIK

- WHEREAS, Aspen Avenue is the only ingress/egress to the Senior Citizens Center and housing complex located in the unincorporated community of Ninilchik; and
- WHEREAS, ordinance 2015-19-24 approved a Community Development Block Grant (CDBG) in the amount of \$118,300 to supplement the cost to pave Aspen Avenue; and
- WHEREAS, the State of Alaska Department of Commerce, Community, and Economic Development administers CDBG program, a federal pass-through grant, to complete public projects within eligible, unincorporated communities throughout the state; and
- WHEREAS, the borough received an amendment notification increasing the CDBG grant from \$118,300 to \$185,153.30; and
- WHEREAS, the amendment increase of \$66,853.30 will reimburse the construction and design costs; and
- WHEREAS, at its meeting of January 24, 2017 the Road Service Area board recommended approval by adoption of RSA Resolution 2017-01;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to execute the grant amendment 15-CDBG-03.A01 and any other documents deemed necessary to expend the funds and to fulfill the intents and purposes of this ordinance.
- SECTION 2. That \$66,853.30 received from the State of Alaska Department of Commerce, Community, and Economic Development "Community Development Block Grant Program" is appropriated as follows:

- Design and engineering costs of \$19,450 to account 434.33950.W5ASP.49311 • for design services; and
- Construction costs in the amount of \$47,403.30 account • to 434.33950.W5ASP.43011 for contractual services.

SECTION 3. This ordinance shall become effective immediately upon enactment.
