Re: Policy on Invocation for Assembly Meetings

Dear Madam or Sir,

I would like to voice my opposition to the Assembly providing an invocation. You have unnecessarily backed yourself into legal problems. Since I have been a lawyer in Homer for 25 years, let me briefly explain why the problem is intractable.

The law on invocations was most recently and most clearly written in 2014 by the US Supreme Court. In *Town of Greece v. Galloway*, the Supreme Court allowed sectarian invocations to be given when the City Council had drawn its speakers at random (and who all happened to be Christian). It held that to require the invocations to be neutral would impose religious beliefs on the pastors. But along the same line, it ruled that while the City Council need not seek a Jewish prayer, it cannot reject it. The City Council <u>must not discriminate against other religions</u>:

The town made reasonable efforts to identify all of the congregations located within its borders and represented that it would welcome a prayer by any minister or layman who wished to give one. That nearly all of the congregations in town turned out to be Christian does not reflect an aversion or bias on the part of town leaders against minority faiths. So long as the town maintains a policy of nondiscrimination, the Constitution does not require it to search beyond its borders for non-Christian prayer givers in an effort to achieve religious balancing.

With all due respect, your policy <u>does</u> discriminate against Jews when you prohibit a Jewish invocation. There are a lot of us who do not pray in Jesus' name. That's not to detract from those who do. But when we are asked to do so, that removes us and tells us that we should not participate. And that is just wrong. A Judeo-Christian concept speaks of a shared background; it does not mean that Jews accept Christ.

So how are you going to fix this? Here are your choices:

- 1) Maintain the current policy and lose to the ACLU; pay their legal fees; and have the current law struck down. Bad choice.
- 2) Revert to the earlier policy of allowing anyone to give the policy. I don't have a problem with this. But a lot of people do.
- 3) Eliminate invocations. Use the money that you would spend on legal fees to do something that glorifies God as a constant reminder to you-let's say hire

a teacher.

Candidly, those are your choices. Obviously, choice # 3 is the best. Please consider it. You have more important things to do than to spend money on yourselves.

I am strongly in favor of this ordinance and urge the Assembly to pass it. There are many reasons I favor doing away with the invocation.

First, times have changed. We are a much more diverse nation and state than we were 30 years ago. With multiple religious organizations and many ethnic groups now in our Borough, it is difficult to please everyone. This issue has now become contentious and divisive with some wanting only one religion to give the invocation, some wanting all comers, and some wanting to restrict which groups can say the invocation. At least two of these options are likely unconstitutional. Separation of church and state helps avoid these sorts of disagreements. I believe this is a strong argument to drop the invocation and just get to Assembly business.

Second, the Borough cannot afford to spend \$50 to \$75 thousand dollars defending an unconstitutional ordinance. We have so many important ways to spend our dollars providing core services, such as education, health and public safety, transportation, and more. I think this is a serious waste of our tax dollars.

Third, we as a Borough stand to gain a huge black eye by having hired the Alliance Defending Freedom (ADF) to handle this issue. ADF was recently added to The Southern Poverty Law Center's active anti-LGBTQ hate groups list. I do not believe it appropriate for the Borough to hire an Outside group with such a divisive reputation. Why are we even hiring an Outside organization? There are not plenty of Alaskan lawyers and our own Borough lawyer?

TO KENAI PENNINSULA BOROUGH ASSEMBLY MEMBERS:

The question of invocations at Assembly meetings will again be addressed with public testimony on March 21st. Judging from past public testimony there will be strong opinions expressed on both sides of the issue. It's good that our Assembly allows for public debate on this issue, however the matter cannot be decided merely by counting how many testify.

Please keep in mind that more important than the number of pro and con voices is the underlying constitutional mandate of separation of church and state. It has proven very difficult to draw up an Assembly policy that meets court ordered fairness. The result has been litigation. That is why I as a secular citizen favor eliminating spoken invocations at Assembly meetings. I propose the Assembly change its traditional out loud prayer into a minute of silent contemplation.

I will be unable to testify in Soldotna or by phone at the Homer Annex on March 21st due to sudden family obligations that call me to Anchorage, and am therefore submitting this statement as part of the official record.

DIANA CONWAY

On March 16, 1776, after a defeat at the Battle of Quebec, "the fledgling Congress sensed the need to rededicate themselves to God's vision," and "put forth a proclamation setting May 17, 1776, as a 'day of Humiliation, Fasting and Prayer.' 'A day of national repentance to obtain God's 'pardon and forgiveness'. Dr. John Witherspoon, a Presbyterian minister, president of the College of New Jersey (later to become Princeton University) and one of the eventual fifty-six signers of the Declaration of Independence," spoke of "God's staggering vision for this country".

"He saw it in the hopes and dreams of his peers – no, his brothers – in Congress. They were statesmen rather than politicians – men whose private morality and public discourse were true to each other and true to God." He recognized as "the three indispensable elements of a statesman and patriot: First, you had to be an active and sincere promoter of '*true and undefiled religion*.' Second, one must '*bear down profanity and immorality of every kind*' because if the people were profane and immoral, then the government would be profane and immoral. Finally, he declared that if an individual oppose what God stood for, he opposed the very foundation upon which America had been built."

" 'But observe that if your cause is just, if your principles are pure, and if your conduct is prudent, you need not fear the multitude of opposing hosts. What follows from this? That he is the best friend to American liberty who is most sincere and active in promoting true and undefiled religion . . . "" pp. 216-218
