I live down the road from where this facility wants to open shop. I am opposed to this business being put on the corner of Murray Lane and Sterling Highway for a variety of reasons:

- 1. This would be a high traffic retail business where dangerous lines could form making it an extreme hazard in this location.
- 2. It is a very precarious location to get on and off of from the Sterling Highway.
- 3. The disruption for the neighborhood would be unnerving.
- 4. This is an area where school buses come to pick up and drop off school children. The facility would be located just off from where the children wait for these buses and are dropped off from these buses.
- 5. There is a church just a few hundred feet down the road.
- 6. There is U S Post Office Cluster boxes right across from the proposed site just around the corner as you turn off the Sterling Highway.
- 7. There is no access to this location directly from the Sterling Highway. The only access is through Murray Lane.
- 8. The traffic this site would generate would be such a safety issue for the children as well as those that live down the road and retrieve their mail from the cluster boxes.

I am opposed to this business being put on the corner of Murray Lane and Sterling Highway for a variety of reasons:

- 1. This would be a high traffic retail business making it a hazard in this location.
- 2. It is a very precarious location to get on and off of the Sterling Highway. There have been several accidents at this intersection over the years including a fatality. The hill to the East makes seeing the extent of traffic approaching from a reasonable distance impossible. This may make people take unnecessary chances to get on the highway when traffic is busy and they have been waiting an extended time to get an opening.
- 3. This is an area where school buses come to pick up and drop off school children. The facility would be located right where the children wait for these buses and are dropped off from these buses.
- 4. There is a church just a few hundred feet down the road. I drive one of the Sunday School busses for the church and do not like the idea of this business being visible to the children and the added traffic and risk to driving the bus for the reasons stated above.
- 5. There is U S Post Office Cluster box right across from the proposed site on the opposite side of Murray Lane.
- 6. There is no access to this location directly from the Sterling Highway. The only access is through Murray Lane. Likewise there is no access for us to get to the church other than Murray Lane.
- 7. The traffic this site would generate would be a safety issue for the children as well as those that live down the road and retrieve their mail from the cluster boxes.
- 8. The disruption for the neighborhood would be unnerving.

My name is Tracey Ratliff, I live at 36387 Penny Lane which is the adjacent property to 36380 Murray Lane (the former Zimco Construction Building). I am writing this letter on behalf of myself and my husband Terry Ratliff, we have lived in this location for almost 30 years and have enjoyed the quiet, family oriented neighborhood it has always been. In that 30 years we have seen numerous changes to the area but this is by far the most disturbing one. My husband and I would like to go on record in protest to the issuance of a license for marijuana cultivation by Fat Tops, LLC.

I am unable at this time to attach pictures of the former Zimco building but feel that the new owners covering all of the windows and doors (both man doors and overhead garage doors) with plywood is an eyesore. I have had people that have come to my home ask me if the building was condemned, I myself wondered what the reason for this was.

I fear if this licensing is allowed to happen it will definitely have a negative effect on the value of our property.

If the unfortunate outcome of this is the issuance of a cultivation license I would strongly ask that caveats be placed regarding the ventilation and waste water disposal of the facility. I certainly am not an expert nor do I know if there are any regulations regarding this within the new laws pertaining to marijuana cultivation. I have done some research however and understand that there have been issues in other states with contamination of surface and ground water effecting not only humans but wildlife and issues with ventilation of noxious odors.

I would ask that the Borough Planning Commission take all this into consideration when determining the outcome of this application.

### **Water Use**

Where is Fat Tops getting water from, a well? The large amount of well water can/will affect all the home owners in the area.

Where is the contaminated water going, into the ground? When and who will be testing the contaminated water going into the ground? Will testing be done for the ground water now and at least yearly?

## Some of the problems growing marijuana in a residential area. \*\*

Growing marijuana inside impacts the health of the surrounding residents.

Common health concerns related to growing marijuana inside a dwelling include the:

growth and release of molds and fungi release of toxins, commercial or industrial chemicals, and fumes

absorption of insecticides, fungicides, solvents and other chemicals used in operations into carpeting, wood, insulation, subfloors and concrete basement floors

general decline in air quality, and contamination of the ground or water supply.

I am not against Fat Tops for what they are wanting to do but this is the wrong location for this type of large operation.

### **Federal Law**

I would think this Assembly may want to put a hold on any marijuana operation's on the peninsula until we know more about what is going on with Federal Enforcement of the marijuana law's. There are many articles found about all sorts of loopholes that can give the DEA an excuse to come down on a grower. For instance, you are not legally allowed to grow or distribute anywhere within 1,000 feet of a school, or more specifically, anywhere where children may gather regularly. That could technically mean a church, a local park, a zoo, a movie theater or even neighbors' houses, if they have children. Now many places as a "Drug Free School Zone" includes the school bus and the school bus stop

### Summery:

According to Mother Jones, roughly one-third of America's marijuana supply is cultivated indoors and the energy needed to power these indoor grow ops is enough to power around 1.7 million homes. As energy is used, greenhouse gases like carbon dioxide and methane are produced at a rate of two pounds of CO2 per joint.

We are putting are children at risk of waiting for the school bus in the morning or when dropped off having to walk past this location. A school bus pulls away after dropping the children off as soon as they are on the side road putting the children in great danger of car's turning off the highway onto Murray Lane, looking to their left to turn in to Fat Tops driveway and not seeing them walking on Murray Ln. Murray Lane has no shoulders to walk on so they walk on the road. The people who live in this area know that.

I do not know how there could be any reason that the Kenai Peninsula Borough would give a permit to Fat Tops, LLC for this location. All the dangers and hazards for children and residents in this area along with a church building and a Sunday school building being less then 1000ft away.
