Our goal is to provide the best service we can with the funds we have. We work to deliver the most cost effective rides possible. CARTS trips are door-to-door and all trips are subsidized – public transportation is subsidized throughout the United States.

CARTS southern Service Area includes the city of Homer and surrounding communities as far as Anchor Point.





# What CARTS is Requesting

CARTS is requesting \$50,000 Borough funds for FY18. A \$50,000 investment from the Borough would allow CARTS to leverage \$119,328 of Federal Transit Administration Section 5311 funds, for a total of \$169,328.

# What the Public Gets from the Borough Funding

In order to balance the budget after not being awarded Borough funds for FY17 CARTS had to suspend weekend service in the central and southern service areas resulting in a loss of more than 6,500 one way trips.

If CARTS is awarded these funds for FY18 we will be able to restore weekend service allowing more than 250 regular weekend riders to get back and forth to work, shopping, church and recreational opportunities.

## **Recent Tech Improvements**

CARTS recently added a Dial-a-Ride Fare map to our website. Customers can Click in the origination and destination zones and their fare will be calculated for them.

CARTS also switched out our Ranger MDTs (mobile data terminals, installed in 2012) for tablets, which offer more flexibility for collecting data and required performance measure information.
