## KENAI PENINSULA BOROUGH ORDINANCE 2016-19-37

## AN ORDINANCE REDIRECTING FUNDS PREVIOUSLY APPROPRIATED FOR VARIOUS SOUTH PENINSULA HOSPITAL EQUIPMENT PURCHASES AND AUTHORIZING THE PURCHASE OF OTHER NEEDED EQUIPMENT

- WHEREAS, the South Peninsula Hospital ("SPH") has identified a number of capital projects that are complete and has requested the unspent funds be redirected for the purchase of various equipment; and
- WHEREAS, the projects that are complete include project number 491.81210.8SH01.48516 emergency equipment with a remaining balance of \$62,669.55; project number 491.81210.15SHN.48516 for miscellaneous equipment with a remaining balance of \$106,797.81; project number 491.81210.16SHS.48516 for various equipment with a remaining balance of \$177,891.82; and
- WHEREAS, SPH is requesting the total unspent funds of \$347,359.18 from the above project be used for the purchase of the following equipment, two Cystoscope instruments that are needed by SPH to bring them up to date with current equipment with an estimated cost of \$80,000; gynecological ("GYN") instruments needed by SPH OB/GYN surgeons to meet the increased utilization and scheduling of GYN surgeries and to address the use of current sterilization practices with an estimated cost of \$30,000; an emergency room ("ER") ultrasound unit will improve patient care with an estimated cost of \$50,000; relocation and renovation of the sleep lab which will also provide additional space for behavioral health with estimated cost of \$75,000; replacement of the current treadmill used to perform stress tests with an estimated cost of \$26,500 and other minor equipment including wheelchairs, beds, crash cart, freezer, automatic doors, medical recliners, electrocardiogram machine and front wheel drive car for SPH and traveler use totaling approximately \$85,859.18; and
- WHEREAS, the South Peninsula Hospital, Inc. Board of Directors recommended approval by unanimous consent at its March 22, 2017, meeting; and
- WHEREAS, the South Kenai Peninsula Hospital Service Area Board recommended approval at its April 13, 2017 meeting;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That funds in the amount of \$62,669.55 previously appropriated for project number 491.81210.8SH01.48516 emergency equipment; \$106,797.81 previously appropriated for project number 491.81210.15SHN.48516 for miscellaneous equipment; and \$177,891,82 previously appropriated for project number 491.81210.16SHS.48516 for various equipment are redirected as follows:

Cystoscope equipment, project number 491.81210.17SHU.48516, in the amount of \$80,000,

GYN equipment, project number 491.81210.17\$HV.48516, in the amount of \$30,000,

ER Ultrasound, project number 491.81210.17SHW.4516, in the amount of \$50,000,

Relocation/renovation sleep lab, project number 491.81210.17SHX.49999, in the amount of \$75,000,

Treadmill replacement, project 491.81210.SHY.48516, in the amount of \$26,500,

Misc. Equipment, project number 491.81210.SHZ.48516, in the amount of \$85,589.18.

**SECTION 2.** This ordinance shall become effective immediately upon its enactment.
