The Purchasing and Contracting Office formally solicited bids for the above mentioned project. Bid packets were released on June 29, 2017 and the invitation to bid was advertised in the Peninsula Clarion newspaper on June 29, 2017.

The project consists of Furnishing all labor, materials, and equipment to upgrade these roads. Work includes subgrade modification, roadbed widening, embankment construction, drainage, ditching and clearing.

On the due date of July 13, 2017 five (5) bids were received and reviewed to ensure that all the specifications and delivery schedules were met. The low bid of \$246,990.70 was submitted by Foster Construction, LLC. The total cost for this project is \$336,700.00 which includes design services, contract services, inter-department charges, and contingencies.

This project has been approved through the Road Service Area Board at their January 24, 2017 meeting approving road projects be included as FY17 capital improvement projects.
