Subject: Enstar Gas LINE

This letter is in regards to the five hundred feet of two inch dia. plastic gas line piping that parallels our property.

Many of the property owners bordering the Kaslof river along with some of the more "deep-pockets" parcels owners at the beginning of Sandwich Ave and beyond are in favor of the gas for heating and household appliances, apparently.

Two of their "spokespersons" somewhat convinced us to entertain the concept of how much more economical natural gas is than oil, wood or propane and changing our appliances from electric to gas.

So we devoted considerable time to do the math on this concept and to our life style circumstances. We also <sup>were</sup> led to believe "...if the majority of parcel owner were in favor of the gas line that the minority would still <sup>have</sup> to pay, proportionately, for the cost of material and labor of its installation.

We did the math and with all the expenses of changing from our present heat sources to natural gas along with our appliance.
