## KENAI PENINSULA BOROUGH RESOLUTION 2018-002

## A RESOLUTION CLASSIFYING 66.5+/- ACRES OF BOROUGH LAND IN THE COOPER LANDING AREA AS RECREATIONAL

- WHEREAS, through the municipal entitlement land selection process a 66.5+/- acre site was identified as potentially suitable for relocation of the Cooper Landing Rifle and Sportsman's Club shooting range; and
- WHEREAS, the Kenai Peninsula Borough has management authority of the subject land which was granted by final decision of the Alaska Department of Natural Resources on July 30, 2014; and
- WHEREAS, the Cooper Landing Advisory Planning Commission ("CLAPC") has made a request to classify the land, which is located in the CLAPC planning area, to recreational; and
- **WHEREAS**, pursuant to KPB 17.10.080 classification provides direction for the management of borough land; and
